Topic Original Report

MO #1-By punching the victim and slapping the victim about the head and face causing injury to same.
MO #2-By pulling out a knife and threatening parties coming to the defense of an assault victim.

Detailed with Ptl. Thibodeaux, at about 1407 Hrs., on 8-21-08 to the area of 1444 Alameda Ave. on the report of a female who was assaulted. The caller, VIC/SHERRY BOSTWICK, advised that the suspects had since left the area.

On my arrival, Ptl. Thibodeaux advised that BOSTWICK's son and his friends left N/B on Alameda, intending to go after the suspects. This group was located at the corner of Lakewood Ave. and Detroit Ave. They were identified as VIC/LEARY and VIC/ advised the following.

stated that the group was at 's home playing basketball in the back yard. While the group was back there, SUS/DAVID SAYRE and SUS/CHRISTINE SAYRE apparently showed up at BOSTWICK's home, looking for . DAVID and CHRISTINE advised BOSTWICK they believe was responsible for stealing their son, OIV/JEFFERY SAYRE's, iPod. later denied this charge. At this time, advised the following.

stated that BOSTWICK told him she was in her front yard when CHRISTINE and DAVID, who used to be BOSTWICK's neighbors in Cleveland, showed up. CHRISTINE started arguing with BOSTWICK about JEFFERY's iPod being missing. CHRISTINE accused of taking it. Without any further provocation, CHRISTINE suddenly began to push and slap BOSTWICK. The fight escalated to CHRISTINE punching BOSTWICK in the face repeatedly with a closed fist. Shortly after this, DAVID jumped into the assault as well by pulling BOSTWICK's hair and punching her in the face. By this time, the fight had caused enough commotion to attract the attention of 's group. , ROBERT, LEARY and then attempted to come to the aid of BOSTWICK.

As the group did this, DAVID retreated back a few feet from the fight. DAVID then pulled out a large lock blade type knife from his pants pocket and yelled "what now niggers?". stated DAVID held the knife up in a threatening manner towards everyone. WIT/BOBBI CONKLE claimed to have witnessed DAVID do this as well from her second floor bedroom window, which overlooked the scene. DAVID continued to yell for CHRISTINE to continue her assault saying "beat that bitch". Shortly after this, the assault stopped. Both DAVID and CHRISTINE then got into a vehicle and left the area S/B on Alameda. No one on scene was able to provide any description of the vehicle DAVID and CHRISTINE left in other than it was a pick up truck.

In checking BOSTWICK, she had obvious redness to the left side of her face. BOSTWICK declined any further medical treatment. This Officer later took photos of BOSTWICK's injury. Ptl. Thibodeaux then took the attached statement from BOSTWICK. BOSTWICK advised she does desire prosecution for the Simple Assault committed against her. , ROBERT, LEARY and all advised they all desire prosecution for the Aggravated Menacing committed against them.

In checking DAVID I found that he has a criminal history, to include; Felonious Assault, Robbery,
