Topic Original Report

MO1/ By creating a substantial risk of harm to property by lighting a garbage can on fire inside a residence.

MO2/ By throwing a female to the ground causing her injury.

MO3/ By being voluntarily intoxicated and a danger to himself and others.

On 8-21-08, at 0440 hours, units were detailed to 1600 Robinwood on a report of a male and female fighting. While enroute dispatch advised the fight was getting physical and a male left the scene on foot.

In checking the area, PO GAMPHER observed a male run and hide in the garage at 1622 Olivewood. The male, later identified as ARA/SAUTER, was highly intoxicated. He he was unsteady on his feet. He was placed under arrest for intoxication and secured in the back of PO GAMPHER's unit.

I responded to 1600 Robinwood and spoke with VIC/SCOTT. She claimed she came home and SAUTER was in her house. He came out of the house and assaulted her on the porch. He assaulted her by slamming her to the ground. SAUTER went back in the house.

SCOTT went in the house a few moments later and found the house was full of smoke. She went into the kitchen and found a fire in the garbage can. She put the fire out with the hose from the kitchen sink. She found that SAUTER had broken several items in her house. SCOTT stated she desired prosecution.

SCOTT had an abrasion on her right elbow. Her jeans were torn on her posterior. She had a scrape on the triceps area of her right arm. She claimed her neck was sore and added that two of her teeth were chipped. SCOTT refused medical attention.

SAUTER is SCOTT's boyfriend. They do not live together. She was unsure why he assaulted her.

I checked the residence and found it was filled with smoke. In the kitchen I observed a burnt paper remains on the stove. The garbage can next to the stove was melted to the ground. Burnt residue was found in the bottom of the garbage can. It appeared as if someone lit papers on fire, on the stove, and pushed them into the garbage can. LFD responded and removed the smoldering items from the residence.

The kitchen is at the back of the residence, on the southwest side of the building. Two bedrooms are north of the kitchen. The dining room is east of the kitchen. The living room is east of the dining room.

Several other items were damaged in the house. A knife set from the kitchen was knocked on the floor. A shelf with some books was also knocked over in the kitchen. A cookie jar from the kitchen was found shattered in the dining room.

In the dining room I found, two chairs were found knocked over and broken. A large framed picture was shattered on the floor. The TV was knocked over. A cabinet door was broken. Household knick knacks were shattered on the floor. A set of shelves was broken.

The eastern most bedroom in the house was the room SCOTT uses. Her phone was smashed, on the floor. A jewelry box was broken on her dresser.

INV DUECHER responded to the scene for photos. He took photos of the damaged property and to SCOTT's injuries.

WIT/PAGE came forward and provided a statement about the incident. He observed a male throw SCOTT down on her porch. The male went inside the residence after that. PAGE heard SCOTT yelling to the male "this is my fucking house Jimmie. Don't come back."

It should be noted that the building was a multiple dwelling structure, with an upstairs unit. We learned that the upstairs unit was unoccupied.

PO GAMPHER transported SAUTER to the station where he was booked for Arson, Assault, and intoxication. He was booked into jail by PO D. MCCARTHY. At the booking window SAUTER's clothes were taken as evidence. PO GAMPHER collected the clothes, tagged them, and secured them in the west garage. SAUTER claimed that SCOTT started the fire.

SAUTER's CCH showed an FBI number of #431320CB2 and a BCI number of B571679.
