Topic Original Report

MO- By having under the front seat of the vehicle he was operating, a white metal pipe with burnt residue commonly used to smoke marijuana

On 08/22/2008 at 0234hrs, I was sitting in the municipal lot at W117TH and DETROIT in unit 218 watching traffic in the area. I observed a silver Mazda approach the intersection Eastbound on DETROIT, then turn Southbound onto W117TH. The vehicle turned rapidly into the left hand lane, and I pulled out to attempt to catch up to it and run a registration check.

As I turned onto W117TH and passed MCDONALDS, the vehicle was nearing FRANKLIN. At 0235hrs, I was passing FRANKLIN, and was traveling at 55mph. The vehicle was in the left hand lane still and was maintaining its distance from my patrol vehicle despite my speed. As I reached MADISON, I observed the vehicle traveling under the railroad tressel, and move from the left lane into the curb lane to pass slower traffic in the left lane. The Mazda then moved back into the left lane after passing the cars. It made both of these lane changes without signaling. I moved into the curb lane and was finally able to catch up to the vehicle near CARBON after reaching a speed of 70mph. A traffic stop was initiated at W117TH and I90.

The driver produced his OL identifying him as (ARA)CASADO. When informed of the reasons for the stop, CASADO said, "I know, I know. I was trying to get to the gas station." He readily admitted to speeding. CASADO said he was heading home after dropping off co-workers in Lakewood, and thus was not driving due to any emergency.

CASADO was found to be under a License Forfeiture suspension 07/25/08-Indefinite. A fee is required.

CASADO was issued Citation #D162945 for DUS and Speed. He was warned regarding the change of course. CASADO was told the vehicle would be impounded, and was asked if there were any items I needed to know about such as needles, knives, guns, drugs, or sharp work tools in the vehicle. He replied, "Not that I know of." During an inventory of the vehicle, I located the listed white metal drug pipe with burnt residue under the driver's seat. I placed it on the driver's seat for a moment and checked the driver's side of the back seat area. At this time, I observed CASSADO watching me carefully. He asked if everything was ok. I informed him of the discovery of the pipe, and he claimed ownership of it. He said there was no other contraband in the vehicle, and none was located. None was located during a search of his person. The pipe was placed into 218 while I completed a citation for the drug offense.

CASADO was issued Citation #M40900 for Drug Paraphernalia. He was informed of his mandatory court date and insurance requirement. CASADO said the vehicle belonged to his girlfriend, (OWN)GARCES. Kufner Towing responded and towed the vehicle. It will be held for GARCES and a licensed driver. CASADO was advised of the release procedures. His OL was confiscated and later tagged to be sent back to the BMV.

As I turned around and proceeded back Northbound toward Lakewood, CASADO walked Southbound and shouted some unintelligible remark as I passed him.
