Topic Original Report

M.O./1: By cutting her boyfriend multiple times with a knife, causing serious harm.

M.O./2: By striking his live-in girlfriend and the mother of his child, in the face with his fist and choking her.

M.O./3: By being voluntarily intoxicated with alcoholic beverage, unsteady on his feet and a danger to himself and others; Having slurred speech, glassy eyes, and a strong odor of alcoholic beverage.

Sgt. L. Wilkins, ma'am:

On 8/24/2008 at 2254 hours officers were dispatched to 1468 W. 117th apartment 15 on a call from ARA/WILLIE BANKS stating he had been stabbed by his girlfriend.

Upon arrival, officers found WILLIE in the front entrance to the apartment building bleeding heavily from multiple lacerations on his upper body. WILLIE had a strong odor of alcoholic beverage on his person, he spoke with slurred speech and had bloodshot, glassy eyes.

Officers Cantlin, Fioritto and Greear found ARA/LATEYA SHANKLIN in apartment 15. Also in the apartment were LATEYA's children, OIV and OIV. SHANKLIN directed officers to the listed knife which was washed and in the kitchen sink. SHANKLIN stated she used the knife against WILLIE because she was tired of WILLIE hitting her. SHANKLIN was bleeding from a small laceration on her right knee. The right side of her face was swollen and had small red marks. The inside of her right cheek was bloody and cut. LATEYA stated WILLIE struck her in the face with her fist.

Dispatch advised WILLIE had a Lakewood warrant for Contempt of Court from a DCI charge. WILLIE was placed under arrest for Domestic Violence, DCI and the Lakewood warrant. LATEYA was placed under arrest for Felonious Assault and secured in Unit 212.

LATEYA was transported to Lakewood Hospital ER in Unit 212. WILLIE was transported to Lakewood ER by Squad 3. WILLIE and LATEYA's injuries were photographed. WILLIE had multiple lacerations to his chest and stomach area, and multiple lacerations on his hands and between his fingers.

LATEYA's mother, OIV/VERONICA SHANKLIN, arrived on scene to care for and

There are two doors to apartment 15. The left door opens to the family room and the right door opens to the kitchen. There were blood drops covering the floor of the entire apartment, with a large pool of blood in the apartment building hallway directly outside the apartment. A trail of blood stretched from the apartment to the front door of the apartment building. The family room contained an air mattress and a table with a computer beside it. The bedroom is to the left of the family room. The kitchen is to the right of the family room.

WILLIE stated the following: WILLIE returned home this afternoon at approximately 1930 hours after staying elsewhere the night before. LATEYA was angry because WILLIE did not come home last night. WILLIE went to bed and LATEYA continued to . LATEYA went to the kitchen and retrieved a knife,

came back to the bedroom and began to stab WILLIE. WILLIE was able to get up and push LATEYA out into the hallway. WILLIE then contacted Lakewood PD.

LATEYA stated the following: WILLIE came home this evening with a six-pack of beer and began to drink. LATEYA stated WILLIE drinks constantly from morning until he falls asleep at night. LATEYA told WILLIE she was unhappy with his drinking and their relationship. She informed him she planned on moving out tomorrow. WILLIE became angry and told LATEYA to leave now and threw beer on her and began to choke her and pull her by the hair. LATEYA picked up her son and began to gather her things. WILLIE pulled away from LATEYA and struck LATEYA in the right side of her face, causing her to fall into a table and cut her knee. LATEYA got up and went to the kitchen to get a knife. LATEYA and WILLIE fought over the knife. LATEYA held the handle of the knife in her hand, and WILLIE was cut numerous times. LATEYA left the apartment and knocked on apartment 12 to ask her neighbors to call the police but no one answered the door. WILLIE called the police, then walked past her to the front of the apartment building. LATEYA waited in the apartment with her children until police arrived.

Both were treated by Dr. Hastings and released. WILLIE received stitches to close his cuts. LATEYA also received stitches to the cut on her knee. LATEYA was transported to Lakewood Jail in Unit 212 where she was booked by CO McCarthy. WILLIE was transported to Lakewood Jail in Unit 219 and booked by CO McCarthy. WILLIE was issued citation M41626 for DCI.

Because of his intoxication a statement was not obtained from WILLIE. WILLIE indicated he does not desire prosecution. WILLIE and LATEYA signed medical release forms. LATEYA provided a written statement. LATEYA does not desire prosecution or a protection order.

A Domestic Violence Incident Sheet was completed. Anita at 696-KIDS was contacted and provided an ID number 486923. Meyer at CWWV was also contacted, as well as Elvira Smith at the Domestic Violence Center.

Sgt. L. Wilkins recorded the call from WILLIE. The recording and the knife were tagged and secured in the property room. LATEYA does not have a CCH. [REDACTED]
