<p>M.O. By grabbing victim and holding something to his back while taking money and cell phone out of his pockets.</p> <p>On 8/25/08, at approximately 2346 hours, P.O. Bly and I were detailed to 1681 Lincoln to speak with a male who said he was robbed. On arrival, we were met by VIC/JOHN T. MELTON. MELTON advised that at approximately 2250 hours he was walking northbound on Lewis into the parking lot of Iggy's bar. He stated that as he got into the parking lot he was grabbed from behind and felt something sharp poking him in his back. A male voice told him not to move. MELTON felt someone going through his pockets.</p> <p>MELTON then heard someone running away. As he turned around, he saw two males, with hooded sweatshirts, running southbound on Lewis. MELTON was unable to give a description of the males.</p> <p>While looking through his pockets, MELTON found \$40.00 cash and the listed cell phone missing. MELTON had his phone deactivated through CPY/VERIZON WIRELESS and called Lakewood Police.</p> <p>It should be noted that MELTON believed the sharp object in his back to be a knife.</p> <p>MELTON desires prosecution in this matter and was advised of the low solvability in this case.</p>
