Topic Original Report

M.O.: By breaking in the side door to the apartment to gain entry, and taking currency, a television, a video game console and games, DVD's, and a digital camera from the owner without his knowledge or consent.

On 8-26-08, at 0032 Hrs, I responded to 1283 Clifton Prado, Apt #2, regarding an apartment that had been broken into. When I arrived on scene I spoke with VIC/JOSEPH VICCARO and learned the following:

VICCARO stated at approximately 1830 Hrs SUS/JONATHAN SMITH arrived at his apartment. VICCARO indicated SMITH is the roommate of his friend, OIV/BOBBY JO. VICCARO is unsure of BOBBY JO's last name or address, but believes she lives around W 121st and Triskett. SMITH arrived at VICCARO's apartment with a friend, who identified himself as SUS/BOB FOX. VICCARO had never seen FOX prior to this incident. FOX and VICCARO were upset because BOBBY JO had taken some of their belongings, and wanted VICCARO to settle it by paying them money. VICCARO refused to pay them, and got into a verbal altercation outside his building. When VICCARO told the males to step away from the vehicle so they could settle the problem, the males drove off. VICCARO described the vehicle as a two door black Ford Probe. VICCARO left his residence a few minutes after the altercation.

When VICCARO arrived home, he found the side door to his apartment was kicked in. VICCARO immediately contacted the police.

1283 Clifton Prado Apt# 2 is a one bedroom apartment. The front entrance is located on the west side of the building, and the side entrance is located on the south side of the building. The side door jamb split where the dead bolt was secured, and was completely separated away from the frame at the top. Entering from this doorway leads into the kitchen. The kitchen cabinets were all opened. VICCARO indicated there were approximately twelve pairs of shoes in front of the stove that were missing, and a digital camera located on the shelves on the west wall was missing.

The light in the family room was on. The cushions from the couch were on the floor, and the contents of the closet were thrown on the floor. VICCARO stated a television, and X-Box 360 were taken off of a TV stand located in the northwest corner of the room. Approximately 580 DVD's that were stacked behind the stand were missing. Four X-Box 360 Video Games, Madden 09', Call of Duty, Army of 2, and Halo 3, were also missing from this area.

The contents of the bedroom had been thrown around the room. The drawers to the dresser, and chest had been opened. VICCARO indicated a shoe box containing \$1400 dollars in cash was taken from the cabinet against the north wall of the bedroom.

Inv. Register arrived to process the scene. Nothing of evidentiary value was found.

While speaking with VICCARO, he received a text message from phone number 216: stating the following: "Jo its bob. I was n da car n i hav ur shit". VICCARO received several calls from this number while we were on scene. The male identified himself as FOX, and said VICCARO owed him money. FOX stated when they get their money, they would give VICCARO his belongings. VICCARO received calls at 0052 Hrs, 0054 Hrs, 0103 Hrs, 0127 Hrs, 0146 Hrs, and two calls at 0147 Hrs.


