Topic Original Report

MO; By concealing on his person, in the front left pants pocket, a knife with a three and one quarter inch blade.

On 08-25-2008, at 1828 hrs, Ptl. Beno and I were detailed to the area of Lakewood and Franklin regarding a group of people passing around what the caller believed was drugs. The caller was anonymous. On arrival, a group of approx seven persons were observed standing in front of 1551 Lakewood Ave , and on the porch of same address.

The group was approached and a black male began walking away from the group and headed towards the north side of the home. He was instructed not to walk away and to return to my location, which he complied. There were several small children on the porch and several adults. The renter of the home, (OIV) JIMMIE M. GASTON was advised of the complaint. He denied any drugs being passed around. Another male named (OIV) STEPHEN A. SZENTENDREI was identified and he also denied possessing any drugs.

The male who had initially attempted to walk away was asked for ID and he advised that he did not have any on him. He was asked his name and DOB which he advised that his name was (AKA)KENNY J. WATT with a DOB of 10-13-1992. He was asked how old he was and he advised that he was 16 years old. Sgt. Favre and Ptl. Beno arrived as back up. The male was then advised that with the date of birth he gave, he was not 16. He then advised that he was going to be 16.

The male was observed to have a chain running from his belt to his pants pocket. He was asked what this was and he advised that it was his wallet. He was asked to pull the wallet out and open it which he complied. The male then grabbed a white card and another card we could not see, and attempted to stick them into a pocket, inside the wallet, that would conceal them. The male was asked what the cards were and he advised nothing. The cards were removed from the wallet and was found to be a State of Ohio ID card. The card identified the male as (ARJ)

was asked why he lied about who he was and he stated that he did not want to be in any trouble. was patted down and in the front left pants pocket, a long , hard , metal object was felt. This was retrieved from his pocket and found to be a lock blade Knife with a 3 1/4 inch blade and 8 inch overall length. was placed under arrest for Carrying a Concealed Weapon (m-1). He was placed into the back of car 221 and transported to the station by Sgt. Favre. Prior to clearing the call, SZENTENDREI came over and advised that the complaint may have stemmed from his rolling his own cigarette and passing it around to the group. He showed us the rolling papers and cigarette tobacco.

At the station, was booked by Jailer Smith for CCW. The knife was tagged and placed into locker 10, in the basement secure storage room . 's mother was contacted regarding picking her son up. The Cuyahoga County Juvenile Detention Home was contacted and Mr. Brannen advised that has a warrant for his arrest for Assault , however, they would not accept him at this time.
