Topic Original Report

M.O.: By using a closed fist to strike the VIC on the neck and back, causing physical harm.

SGT Spaetzel, Sir,

Detailed to the front of 12650 Detroit on the report of an assault on 8/20/2008 at 1524hrs. Arrived to find SGT FAVRE, CAPT HASSING, and SGT SPAETZEL with a group of juveniles. One of the juveniles, VIC/ , was the subject of the assault. After helping to clear away the rest of the juveniles from the scene, I learned that the assault took place in front of Garfield, 13314 Detroit, approximately 20 minutes prior to my arrival.

advised that she had been walking with a group of friends W/B on Detroit in front of Garfield. SUS/ approached and began yelling at her, accusing her of saying disrespectful things behind her back. and had been friends for over 5 years, but had a recent falling out. pulled 'S head down and began striking her with a closed fist on the back of the neck and on her back. thinks she was also punched in the face, but is not certain. eventually stopped and left the scene, yelling that "will get it" and that "you're mine." stated that she did not attempt to defend herself from . complained of slight pain to her neck and back, but declined medical assistance. did not have visible injuries to photograph. advised that lives at Lark . wishes prosecution and completed a written statement.

WIT/JONATHON UTRATA was also at the station when I arrived. UTRATA advised that he was also on Detroit across from Garfield during this incident. UTRATA observed a female approach the group of juveniles, including . UTRATA described her as a black female, appx. 5-0, 105lbs, with shoulder length black hair. tried to back away from the female. The female struck in the neck and back, all while attempted to get away. UTRATA approached and assisted her to LPD. UTRATA can identify the female if he sees her again.

After speaking with and UTRATA, I went to Robin to inform 'S mother, OIV/JOY BEARER, of the incident. BEARER knows and confirmed the address that gave me. BEARER wants prosecuted.

I attempted to speak with or a family member at ' residence at Lark with negative results.
