Topic Original Report

On 8-29-08, at 0323 Hrs., (COM) ANTHONY HOTY called police to the rear parking lot at 18605 Detroit Ave to report that his friend, (SUB) SHANNON FELL, was passed out in her vehicle. HOTY also advised that she may have been sexually assaulted.

P.O. HAYES and I responded to the scene. FELL was in the back seat of her listed Mitsubishi Eclipse. She was being treated by (OIV) MELISSA DALEY, a nurse at Fairview Hospital.

FELL was highly intoxicated and not able to communicate with officers. FELL was vomiting and there was feces on the drivers seat. FELL was wearing nothing, but a blue t-shirt.

I spoke with HOTY who stated that a male flagged him down because he saw FELL and him in the bar together and knew they were friends. This male told HOTY that FELL was passed out and naked in her vehicle.

HOTY went to FELL's vehicle and found FELL completely nude and intoxicated. HOTY was not sure what happened to FELL, but he stated she started doing shots when she arrived at the bar yesterday at 2330 Hrs.

(OIV) CHRISTINE SEGURA and (OIV) RICHARD HWODEKY were both working at the Harry Buffalo. They assisted HOTY in trying to wake FELL up and they gave FELL a t-shirt to put on. HOTY then called police.

HOTY stated that he heard a male in the bar earlier bragging about how he just had sex in the parking lot. HOTY stated he knows this male as (OIV) ROBERT DUSSAULT.

SEGURA also knows DUSSAULT. She stated that FELL was making out with him in the bar. HWODEKY stated he saw FELL making out with guys and girls in the bar.

I attempted to speak with FELL, but she would only say she wanted to go home.

I called SGT. KAUCHECK and a rescue squad to the scene. SQUAD 2 arrived a short time later.

After advising SGT. KAUCHECK of the situation, it was determined to treat FELL as a victim of a sexual assault and the vehicle as the crime scene.

INV. PICKENS and INV. FIORITTO responded to the scene to process the vehicle and any evidence inside of it.

Lakewood Paramedics transported FELL to Fairview Hospital for treatment.

I responded to Fairview Hospital. FELL was more alert and communicating with nurses there. I was able to speak with FELL and she advised the following:

FELL got to the Harry Buffalo at 0030 Hrs. She stated she was drinking shots and beer. FELL stated she went out to her car and engaged in consensual sex with DUSSAULT.

FELL stated that DUSSAULT is her friend and she does not feel she was sexually assaulted in any way. FELL stated she just had too much to drink and passed out in her vehicle after having sex. FELL stated she was sorry.

I advised FELL that her vehicle had been towed for evidence. Initially it had been towed to the west garage for processing, but when it was learned that no crime had been committed, Kufner's towed the vehicle to their lot. I instructed FELL on how to retrieve the vehicle. FELL'S clothing was returned to her in the E.R.
