Topic Original Report

MO: By actively pulling away his arms and spitting at officers during the course of his lawful arrest.

MO: By creating a condition which is physically offensive to persons by spitting on victim which served no lawful or reasonable purpose.

Sgt. Gannon, Sir;

On August 30, 2008, at approximately 1940 hours, Ptl. Leanza and I were flagged down by a male, later identified as VIC/WILLIAM PEARCE. PEARCE stated that there was a black male walking eastbound on Detroit flipping off cars and cursing. PEARCE stated that the male appeared to be confused and was concerned for his welfare. PEARCE then pointed out the male walking on Detroit towards our location.

We approached the male and asked where he was headed. The male yelled that he was fine and he was not going to talk to us. The male was later identified as ARA/ROBIN SIMMONS. He then walked towards PEARCE, turned his head and spit on PEARCE in the presence of officers. The spit landed on the right side of PEARCE. Ptl. Leanza advised SIMMONS that he was under arrest and to put his hands behind his back. SIMMONS then actively resisted arrest by pulling his arms away and spitting at officers.

SIMMONS was secured in handcuffs and placed in the rear of unit #215. PEARCE provided a written statement and stated that prosecution was desired.

SIMMONS was transported to the station and booked by C.O. Smith for resisting arrest and disorderly conduct. SIMMONS was issued citation numbers M41760 for resisting arrest and M41759 for disorderly conduct.
