Topic Original Report

M.O.: By striking his spouse in the head with his hand, and causing injury.

Lt. Warner, Sir:

On 08/30/2008, at 2356 hours, officers were detailed to the area of Edwards Ave. and the Railroad Tracks, on the report of a male hitting a female in the face. On arrival, I observed VIC/PATRICIA L. WILLIAMS lying on the gravel just south of the railroad tracks, near the west sidewalk on Edwards Ave. PATRICIA was crying and repeatedly screaming "I can't believe he hit me". Kneeling beside her was COM/GEORGETTE M. PATTERSON. Standing a few feet back was ARA/MATTHEW P. WILLIAMS, her husband.

MATTHEW volunteered that he struck PATRICIA, his wife, in the head with his right elbow because she had slapped him numerous times. MATTHEW was handcuffed, and informed he was under arrest for Domestic Violence. MATTHEW was read his Miranda Rights, which he indicated he understood.

MATTHEW then explained that he and PATRICIA had been arguing over the previous couple of hours because she was accusing him of looking at, and flirting with, other women, while the two were drinking at Johnny Malloys. PATRICIA eventually left the bar, walking N/B on Bonnieview Ave., and into the Oak Tree Manor parking lot, heading E/B. MATTHEW stated that he followed her, that they continued to argue, and that after she slapped him near the tracks on Edwards Ave., he responded by striking her with his elbow, causing her to fall to the ground.

An EMS squad arrived on scene, and transported PATRICIA to Lakewood Hospital. Inv. Mladek followed the squad to the hospital. See Inv. Mladek's supplement for further details regarding her injuries and statements.

PATRICIA was provided a social resources card.

While on scene, I spoke with PATTERSON. PATTERSON advised that she was inside her apartment, on the second floor of the Oak Tree Manor, when she heard and saw PATRICIA and MATTHEW in the parking lot arguing, on and off for approximately five minutes. MATTHEW was following PATRICIA as she walked back and forth across the parking lot. PATTERSON then indicated that she saw MATTHEW strike PATRICIA with an open hand across her face, causing PATRICIA to fall to the ground. PATTERSON then called 911, and ran out to help PATRICIA. PATTERSON provided a written statement.

Three other witnesses, WIT/JAMES P. TROWBRIDGE, WIT/COREY J. FERANDA, and WIT/LOUIS S. FERANDA, all residents of the Oak Tree Manor, with apartments overlooking the parking lot, provided statements as well. All related essentially the same sequence of events provided by PATTERSON. It should be noted that none of the four witnesses observed PATRICIA hit MATTHEW.

MATTHEW was placed in Unit 214, and transported to LPD by P.O. Brown and P.O. Bly. MATTHEW was then booked into the jail by Reserve Officer Dennis McCarthy. MATTHEW claimed that his lower lip was injured after being struck by PATRICIA; we observed minor swelling, and redness to the lip. Inv. Mladek took photographs of MATTHEW's lip.
