Topic Original Report

On 8/31/08, at 1855 Hrs, Inv. Mladek and I responded to 15705 Madison to meet a female who was trying to retrieve her property. When we arrived on scene, we were met by SUB/SADAEA MOSS and learned the following:

MOSS indicated she was visiting her friend, COM/BRIANNE UNDERWOOD, earlier this evening. MOSS and UNDERWOOD were sitting on the couch when UNDERWOOD asked to use MOSS's phone. UNDERWOOD became upset with MOSS because of a call she received from another female. MOSS stated UNDERWOOD began hitting her in the face, ribs and legs at this time. MOSS stated she started putting on her clothes while MOSS struck her. UNDERWOOD then threw the rest of MOSS's clothing down the stairs and told her to leave. While MOSS was at the bus stop, UNDERWOOD approached her and asked her to come back inside. MOSS agreed. While inside, MOSS received a phone call from the same female she received one from earlier. MOSS stated this made UNDERWOOD upset. UNDERWOOD struck her in the face, mouth and arm.

MOSS said the lock to UNDERWOOD's front door is broken, so she had to use a butter knife to release the lock to exit. As MOSS tried to leave, UNDERWOOD grabbed MOSS's backpack, and took ten dollars from her pocket. MOSS left and contacted her father. MOSS later contacted the police in an attempt to retrieve her property.

MOSS had a swollen top lip, bruises on her right the left side of her ribs and back, and had bruises on her left thigh. MOSS indicated she desired prosecution. I obtained a written statement, while Inv. Mladek took photos of Moss's injuries.

While speaking with UNDERWOOD we learned the following:

UNDERWOOD stated she and MOSS got into a verbal argument over a text message MOSS received from another female. UNDERWOOD stated they argued for about an hour, and she told MOSS to leave. MOSS initially refused to leave so UNDERWOOD began to throw her belongings down the steps. After MOSS left, UNDERWOOD blocked the front door with her couch, because the lock on her door was broken.

UNDERWOOD stated the next thing she saw was MOSS walking through the kitchen area towards her. MOSS got on top of UNDERWOOD, who was lying down, and began to choke her. UNDERWOOD stated she started to strike MOSS in the sides, face and back at this time. MOSS finally stopped and left out the front door.

UNDERWOOD found the screen to her kitchen and bedroom cut. The window in the kitchen is directly next to the rear door. UNDERWOOD stated MOSS has seen her open this screen and reach through the window to open the door in the past when she has been locked out.

UNDERWOOD did not have any visible injuries, and stated she desired prosecution. Inv. Mladek obtained a written statement from UNDERWOOD and took photos. UNDERWOOD denied having any of MOSS's property. She allowed Inv. Mladek to check her apartment, and nothing was found.
