NARRATIVE

Topic Original Report

M.O. By forcing screen and entering occupied residence without the permission of the owner.

M.O. By being voluntarily intoxicated in danger of harm to himself and others.

On 9-1-08, at 2342 hours, INV.PICKENS, INV.FIORITTO and I were detailed to 2114 Glenbury on the report of COM/JAMES WATSON stating that his downstairs neighbor broke into his apartment and was breaking things. INV.PICKENS and INV.FIORITTO arrived on scene first and learned that ARA/SCOTT PITTS entered the upstairs apartment through a bedroom window that had the screen torn away from it. JAMES advised that PITTS had just left prior to Officers responding. He advised that PITTS lives below him.

When I arrived on scene, I observed that the front door to 2112 GLENBURY was open. I yelled for PITTS to come to the front door. PITTS eventually yelled back saying that he was in the bedroom. PITTS was located in the bedroom lying on the bed. He was highly intoxicated with bloodshot glassy eyes and a strong odor of an alcoholic beverage on his breath. PITTS had slurred speech and was hard to understand. I also observed that the front of PITTS's shirt and pants were wet. After I asked PITTS to stand up, I observed that he was unsteady on his feet. PITTS was arrested for Burglary and DCI.

I spoke with JAMES, VIC/NANCY WATSON and VIC/ROBERT WATSON about what occurred. ROBERT stated that he heard stomping and a pounding noise coming from the rear stairwell. He told his mom, NANCY and father, JAMES, to lock the doors because PITTS was highly intoxicated. ROBERT stated that he encountered PITTS earlier and that he was drunk. ROBERT advised that he then heard the screen to the rear bedroom being torn. He advised that he locked himself in the bathroom because he is scared of PITTS. ROBERT stated that he heard something being thrown around in the dining room. He advised that he told JAMES to contact the police. ROBERT stated that he walked into the dining room and observed PITTS sitting at the dining room table eating. ROBERT advised that PITTS told him "don't you stomp by me like that." ROBERT indicated that PITTS then threw a coffee maker on the ground. ROBERT stated that PITTS then went downstairs.

ROBERT stated that he was afraid because PITTS becomes violent when he drinks. He advised that no one gave him permission to enter the apartment. ROBERT indicated that he desires prosecution. ROBERT gave written statement.

JAMES and NANCY gave the same account as ROBERT of what had transpired. JAMES stated that PITTS had assaulted him in the past, see report 08-006429 for further. JAMES indicated that the assault case has not gone to court yet. He advised that PITTS is his landlord and that he thinks he is allowed to come in whenever he wants. JAMES stated that PITTS gets violent when he drinks and that he is afraid of him. Both JAMES and NANCY advised that they desire prosecution.

PITTS entered 2114 Glenbury by going up the rear stairwell to the back door. He then tore the screen away from the window in the SW bedroom. He went to the kitchen and turned on the stove in attempt to make food. I observed that there was a coffee maker on the ground. INV.FIORITTO took photos of the coffee maker and of the screen. The scene was not processed due to PITTS being at the residence on numerous prior occasions.
