

Topic Original Report

MO; By pushing in first floor front porch screen and rear bedroom screen to gain entry into home, then removing listed property without permission.

On 9-4-08, at 1441 Hrs., INV. KULCZYCKI and I were detailed to 2111 Lewis on the report of a Burglary. On arrival, I spoke with VIC/MARK ROHDE, who said he left his home briefly and when he came back he noticed his computer was missing from the dining room table.

Note, ROHDE lives on the first floor of the duplex home. ROHDE said he looked around his home, he noticed the front living room window screen pushed in and the east bedroom window screen pushed in too. RHODE said all his X-Box C.D. games were missing from the east bedroom, bottom portion of the television console.

ROHDE said he was missing his Play Station Three gaming system from the living room and two Play Station Three C.D.'s that were on a television console.

ROHDE said he did not see anything else missing.

I spoke with upstairs tenants', OIV/MARIO BROWN and OIV/JAMES BROWN who were outside in the backyard when we arrived there. MARIO and JAMES said they had left their home at 1345 Hrs. this day and came back home from the store at 1415 Hrs.

I asked MARIO if he saw anything. MARIO and JAMES said neither saw anyone there. However, MARIO said an old friend of his SUS/GEORGE LAPSLEY just came over unexpectedly today with another adult B/M, SUS/FNU MNU LNU prior to them leaving for the store at 1345 hrs. this date.

MARIO said he has known LAPSLEY for about one year and used to work with him at his present job. MARIO said LAPSLEY brought this B/M into his home and he did not appreciate that. MARIO said he does not want anyone he does not know personally to come into his home. MARIO said LAPSLEY and the B/M left when they went to the store.

MARIO said he thinks LAPSLEY and this B/M probably broke into ROHDE's home. MARIO said that he does not know where LAPSLEY presently lives. MARIO said that LAPSLEY moved to Pittsburgh, Pennsylvania a few months ago. and believes he is just here visiting now.

MARIO and JAMES were cooperative, I asked them if they would take a polygraph and they both said "yes." MARIO and JAMES had nothing further to add.

I went to 2110 Lewis (one west), nobody was home and I left a canvassing form in the front door. I went to 2115 Lewis (one south), nobody was home and I left a canvassing form in the side door there. Athens is directly north of this home and to the east is a home, but it has no view of ROHDE'S home.

ROHDE will prosecute in this matter.
