Topic Original Report

MO:By giving a false name and DOB to police officers to conceal the fact that she has an active warrant for her arrest.

MO:By having in her possession a baggie containing 1.4 grams of marijuana.

Sgt Eschweiler Sir:

On 9/4/08 I was on patrol on W117th between Franklin and Madison when I noticed the listed auto. I ran the plate randomly through LEADS and learned that the listed owner, ARA/EUREKA BARBOUR, had a warrant for her arrest. It appeared based on the physical description that BARBOUR was the passenger in the auto. The auto then made a turn into the 5/3rd bank lot and proceeded to drive W/B through the lot and exiting onto Coutant. The auto then proceeded E/B on Madison into Cleveland. Due to traffic I could not stop the auto until W112th/Madison.

I spoke to the driver, SUB/TOMMY DAVIS, and advised him of the reason for the stop. DAVIS said that the passenger was not BARBOUR but AKA/PATRICE (last name unknown). DAVIS was asked several time for a drivers license but only produced an ID card. DAVIS said that he is not allowed to drive. DAVIS said that PARTICE is BARBOUR's cousin. DAVIS could give no other identifying information about PATRICE.

At the same time PATRICE was identifying herself to Ptl Gampfer as AKA/PATRICE D SMITH with a DOB of 10/21/1982. While speaking to DAVIS he kept looking at PATRICE and stammering his answers or would not answer at all. I had DAVIS step from the auto. DAVIS said that he nothing illegal on his person and gave me consent to check his pockets for contraband. DAVIS said that he has no job but had approx \$300.00 in his front pockets. It was split between the front left and front right pockets.

We checked the in car BMV image of PATRICE and found that she was in fact BARBOUR. When we confronted BARBOUR she said that she knew about the warrant and did not want to be arrested. The warrant for BARBOUR is out of GOV/LINNDALE PD for non payment of a traffic ticket. It was confirmed by M Sowders. BARBOUR was later transported to I-90 and W117th where she was turned over to unit #41.

In running DAVIS, he is Failure to Reinstate. DAVIS is under an FRA suspension from 12/22/06 to 12/22/09. DAVIS claims that he was driving to Metrohealth hospital so that PATRICE could seek medical treatment. DAVIS explained that BARBOUR had some type of pregnancy complications yesterday and now she needed to go the hospital. DAVIS could not explain why he did not call LPD for a squad if BARBOUR needed medical attention. DAVIS also did not want us to call one to the scene.

In speaking to BARBOUR she confirmed being at Merto yesterday. She said that she was having some light vaginal bleeding but did not require medical attention at this time. She was aware that DAVIS has no license. BARBOUR also mentioned that they were driving because DAVIS had to make a "stop" and that is why they were out. BARBOUR would not elaborate on what type of "stop" DAVIS was going to make.

Based on the totality of the circumstances it did not appear, at this time, DAVIS was driving due to an emergency situation. He was issued citation D165909 for DWUS, Giving False Info during a traffic stop.

The car was searched incident to arrest. It should be noted that there was hot Chinese food located in the front seat, indicating they stopped to eat as well, before going to the hospital. In BARBOUR's purse I located a baggie of marijuana. BARBOUR admitted that the marijuana was hers. BARBOUR was issued citation D164578 for Wrongful Entrustment. She was also issued citations M41074 and M41075 for False Info and Drug Abuse (MM).
