Topic Original Report

MO- By having concealed and ready at hand in the center console of his vehicle, a black handled hunting type knife with a 5" blade

MO- By having in the driver's door pocket of his vehicle, a partially burnt white paper cigarette containing marijuana

On 09/05/2008 at 0201hrs, I was Westbound on MADISON at WARREN. I observed a white Ford Explorer stopped for the red light Southbound on WARREN at MADISON with only its parking lights on. I turned into the WALGREENS' lot off of REVELEY, and proceeded to the exit on WARREN. I observed the Explorer pass my location Southbound. It still was operating with only its parking lights on, and I could see the front license plate was not attached to the front of the vehicle, but laying on the dashboard. I pulled out of the lot, and a traffic stop was initiated at WARREN and BAYES.

The operator produced his OL identifying him as (ARA)SUSKO. He was informed of the reasons for the stop, and activated his headlights at that time. He said he had just left a friend's house on GLADYS. He also said that his front license plate bracket was damaged by Baker Motors when his vehicle was towed recently.

I completed traffic Citation #D165607. PTL. PERHACS arrived on-scene to assist. I had SUSKO step out of his vehicle so I could explain the Citation to him. SUSKO's driving record reflected 2 prior In-State Drug Offense Suspensions, so I decided to attempt to get consent to search SUSKO's vehicle believing he may have drugs in the vehicle or on his person.

After issuing Citation #D165607 to SUSKO and advising him he was free to go, I asked if he had anything illegal in the vehicle. He said he did not, but mentioned having a knife in the center console. He granted consent for me to search the vehicle. Upon opening the driver's door, I observed a partially burnt white paper cigarette in the driver's door pocket. This cigarette was made using rolling papers, so I picked it up and examined it closer. I was then able to see a green, leafy, vegetable matter which through my training and experience, I recognized as marijuana. In the center console, I located a black handled hunting style knife. It was contained in a black leather sheath.

I placed the marijuana cigarette in a clear evidence baggie, and placed the baggie and the knife in car 202. SUSKO was asked if he had anything illegal on his person. He said no and granted me permission to search. I located a small clear plastic ziploc type baggie in the right front small pocket of SUSKO's jean shorts. These types of baggies are commonly used to hold drugs. When I removed the baggie, SUSKO remarked that he must have smoked the marijuana already. The baggie was empty and disposed of.

SUSKO was advised of the additional charges. He indicated he keeps the knife for protection as the places he drives aren't safe neighborhoods. He said the marijuana cigarette must have been left from another day. He was issued Citation #M41354 for CCW(M), and #M41355 for Drug Abuse. He was advised of his court date. SUSKO was polite and cooperative during the stop.
