<p>Sgt. L. Wilkins, ma'am:</p> <p>On 9/6/2008, at 0043 hours, officers were dispatched to McCarthys, 16918 Detroit Avenue, on a call that a male and female were fighting. While en route, dispatch advised the couple had moved east to the area of Detroit and Edwards.</p> <p>Upon arrival, officers found SUB/LAUREN MARKHAM at Edwards Park. MARKHAM stated her ex-boyfriend, SUB/CHARLES WESTFALL, had attacked her while she stood outside McCarthys. MARKHAM further stated the following: MARKHAM was standing outside McCarthys with OIV/BRANDON GOULD and OIV/MARK BULZAN. WESTFALL suddenly took her cell phone from her hand. MARKHAM did not know WESTFALL was at McCarthys. WESTFALL walked east on Detroit and MARKHAM followed asking for her cell phone back. At Detroit and Edwards, MARKHAM threw WESTFALL's phone to the ground and pushed her into a parked car. The two became involved in a heated argument and GOULD separated them. WESTFALL left the area northbound on Edwards.</p> <p>GOULD and BULZAN gave the same account of the incident.</p> <p>Officer checked the area for WESTFALL with negative results. No one would answer the door at 1255 Ethel.</p> <p>MARKHAM had no visible injuries and did not desire medical attention.</p>
