

	<p>MO-By taking gutters from the victims building without permission to do so.</p> <p>Detailed on 9-7-08 at about 0817 Hrs. to 12608 Madison Ave. (VIC/ST. CYRIL & METHODDIUS CHURCH) on the report of two sections of gutters stolen sometime overnight. Inv. Geary also arrived to assist. On Officers arrival we spoke to COM/BRUCE MAYORNICK who advised the following.</p> <p>MAYORNICK stated that he left ST. CYRIL's last night around 1800 Hrs. At that time he believed that the Church was in good order and the indexed gutters were in place. On his arrival at about 0745 Hrs. this morning, MAYORNICK stated that he walked around the perimeter of the building and observed two sections of gutters missing. Both sections were taken from the east side of the building facing Lakewood Ave.</p> <p>The first section was made of aluminum and ran from a downspout about halfway up the side of the building just north of the side door. The second section was taken from a corner of the building just south of the same side door. This section was made of a heavy gauge copper. This area is located away from the general public's view and hidden behind a large tree.</p> <p>Inv. Geary observed some fresh boot prints here but none were clear enough to get a photograph or impression of. This Officer later took photos of the damaged areas. See photo sheet for details.</p> <p>MAYORNICK was advised on the report and given the numbers for his records. MAYORNICK stated that should a suspect be developed, ST. CYRIL's would desire prosecution in this matter.</p> <p>It should be noted a prior arrest was made for a similar incident at ST. CYRIL's on 8-27-06 by Ptl. Molnar. See report #07007424 for details. Two of the suspects from that report were found to reside at 1632 Lakewood. At the time of this report, no signs of ST. CYRIL's missing property was observed in plain sight in a vehicle or garage at this address.</p>
