

Topic Original Report

MO - By entering the victim's apartment by pushing in a window screen and then taking money from inside.

On 9-7-08, at 0012 Hrs., (VIC) DAVID KENNEDY called police to his apartment at 1386 Cranford Ave #1A to report a burglary. INV. ALLEN and I responded to the scene. I spoke with KENNEDY and learned the following:

KENNEDY left his apartment on 9-7-08 at 1800 Hrs. The doors were locked when he left, but windows were left open with the screens in place. When KENNEDY returned home today at 0010 Hrs., he found the back door to the apartment was slightly ajar.

KENNEDY went inside and saw some loose change on the floor in the living. He also found the screen from a rear bedroom laying on the floor. KENNEDY left and called police.

In looking around the apartment, it appears the suspects entered by pushing the screen in on the bedroom window on the S/W side of the building. The window is only four feet from the ground outside and easily accessible.

Once inside, the suspects removed a cigar box filled with loose change from a book shelf in the living room. The suspects also entered the S/E bedroom and removed some more loose change and money from a dresser drawer. Nothing else was taken or gone through.

It appears the suspects left out the rear door as KENNEDY found this open when returning home.

KENNEDY has no suspects. There was no answer at the other apartments in the building.

INV. ALLEN took photos and processed the scene. He found no evidence of value.

KENNEDY desires prosecution. He was advised of the low solvability factor.
