Topic Original Report

MO-By opening kitchen window at victims address and take property without permission.

Detailed on 9-9-08 at about 1637 Hrs. to 1434 Hopkins Ave. on the report of a house broken into and items missing. Inv. Malloy also responded to assist. On our arrival Officers spoke to VIC/AMY WATSON who advised the following.

WATSON stated that she went on the Susan G. Komen 3 Day Breast Cancer walk on 8-22-08. WATSON returned home late in the evening of 8-24-08. WATSON stated that she takes the indexed Adderall for an ADHD disorder she has. WATSON stated that for the walk, she did not take the whole prescription bottle with her since she was going out of town. WATSON stated that she only took what she needed. WATSON stated that on her return she was unable to find the medication. WATSON added that she did find a kitchen window partially open on her return home that she did not recall leaving open when she left.

WATSON stated that Adderall is a Schedule II drug. WATSON stated she had just had the prescription filled near the end of 7-08 and it was for 90 days. WATSON stated she contacted the pharmacy she had it filled at and also her insurance. WATSON was advised that since it was a schedule drug, she would not be able to have it refilled unless a police report was made. WATSON did not initially want to make a report but eventually came to the front counter of LPD and spoke to Ptl. Eikens about the matter. Ptl. Eikens took a Property Lost report from WATSON on 9-5-08. It should be noted that report indicated that the drug may have accidentally been knocked into a garbage can and later thrown out. WATSON stated she was unable to find the drug in the garbage.

WATSON stated she knew she would be going through withdrawal from the Adderall. After the drug was completely out of her system, she would start a new course of treatment. WATSON stated that after making the initial report with PIO EIKENS she checked her apartment further and found other property missing. WATSON now believes that someone may have entered the apartment and took the indexed iPod and glass "Winking Lizard" beer stein containing miscellaneous change. WATSON stated all of these items were last seen on top of the dishwasher in the kitchen. WATSON stated that the beer stein was full of mostly U.S. quarters, dimes and nickels. The dishwasher is located directly in front of the kitchen window WATSON found open.

The residence at 1434 Hopkins is a upstairs/downstairs duplex. 1434 is the downstairs unit. The likely point of entry is the kitchen window. This window is the furthest south window on the west side of the home. No other areas of the home displayed any signs of having been gone through at the time of report. WATSON stated that she has no suspects in this matter.

Inv. Malloy processed the scene and found nothing of value. See his photo sheet for details. WATSON was advised on the report and given the number for her records. Disp. Kappa later entered the iPod into LEADS as stolen.
