	<p>Sgt. Gannon, Sir:</p> <p>On 09/09/2008, at 0319 hours, P.O. Leanza and I were detailed to 1578 Larchmont Ave. on the report of a fire. On arrival, smoke was coming out of the front door. I also observed COM/LESTER E. BOEHNEN on the front porch, performing CPR on a female, subsequently identified as SUB/LISA A. BRADLEY. BRADLEY was lying on the floor of the front porch. BOEHNEN indicated that he is the landlord of the house, and lives upstairs, 1576 Larchmont.</p> <p>LFD began treatment as we arrived, and entered the house to extinguish the fire. See Fire Marshall Gilman's report, 08-004420, for details. Inv. Deucher arrived on scene for photographs.</p> <p>BRADLEY was transported by EMS to the Lakewood Hospital Emergency Room, where she was treated by Dr. Gabrin. BRADLEY was unresponsive to treatment, and was pronounced dead at 0355 hours, on 09/09/2008. Lakewood Hospital advised they would contact the coroner and provide that office with all necessary information.</p> <p>We identified OIV/HUBERT H. WILDMAN, BRADLEY's father, as next of kin. WILDMAN's listed address is in Canton, Ohio; Dispatch contacted Stark County SO for notification purposes. Stark County SO contacted WILDMAN, and informed him to contact LPD. WILDMAN then called LPD, and I informed him of BRADLEY's death. WILDMAN was provided all necessary information.</p>
