Topic Original Report

MO-By forcing open the rear door at the victims residence and taking television from area without permission.

Detailed on 9-9-08 at about 1702 Hrs. to 2034 Quail Ave. on the report of a home broken into. Inv. Malloy also responded to assist. On our arrival Officers spoke to VIC/BILLY MASON who advised the following.

MASON stated that he lives in the home with his two daughters, OIV/ and OIV/ . MASON stated that both and went to school this morning as usual. MASON stated he left around 1000 Hrs. to go out looking for a job. MASON stated he is currently laid off from his union local and he is looking for more steady work. MASON stated he was out job hunting all day and eventually returned home around 1640 Hrs. At this time he found a shoe rack the family keeps at the top landing of his steps was moved. The rack normally faces in an east/west direction and was now found facing a north/south direction and was also on the top steps leading to his home. In checking the door, MASON found that it had been forced open. MASON checked around inside the home to make sure the suspect was not still there and to see what, if anything, was missing. Once MASON found no one was there, he left to go call LPD.

In checking the home Officers found the following. 2034 Quail is an upstairs/downstairs duplex. MASON, and live in the upstairs unit. MASON stated that the only entrance for his unit is through the back door. Upon entering through this doorway, you end up in a common hallway. The stairs leading up to MASON's home are on the north wall there. The door to MASON's home showed signs of force in the area of the lock. Score marks were visible on the frame and the insulation adjacent to the lock was damaged. This area was processed and Inv. Malloy retrieved some latent prints. See his supplement for details.

The suspect then proceeded into the home targeting MASON's bedroom on the west side of the home, the living room on the north side, 's bedroom in the northeast corner and 's bedroom in the southeast corner of the floor.

The only item found missing at the time of this report is the indexed television. The television was taken from an entertainment center located on the south wall of the living room. MASON stated neither nor were available at the time of report. MASON stated he would check with both of them to make sure nothing is missing from their rooms. MASON added that he did not have any further information on the television so it could not be entered into LEADS.

MASON added that he has "scumbags" for in-laws but none of them, to his knowledge, know where he and his children live. MASON had no suspects in mind at the time of report. MASON was given the number for his records and advised on the report.

In speaking with the neighbors, the resident of 2026 did not see anything unusual. The downstairs resident of 2034 was not home. The resident of 2036 did not apparently speak very much English. The resident at 2038, OIV/CHERYL BRADBURY, stated she sees "a lot" of traffic coming into and out of the residence at 2034. BRADBURY is unsure if those people are making an effort to visit the upstairs or downstairs residents. BRADBURY estimates that an excess of 20 people a day make the journey.
