	<p>M. O. By breaking open a door to a residence with an unknown object, in an attempt to gain access to the residence.</p>	
	<p>On 9/7/08, at approximately 1621 Hrs, officers were dispatched to 12002 Lake apt. 20, on the report of a resident finding the door to his apartment forced open.</p>	
	<p>Upon arrival we spoke with VIC/NICHOLAS J. BRILLA, who stated that when he returned home from work he had found his door unlocked and slightly open. BRILLA said that he had left around 0800 Hrs on 9/7/08 and had closed and locked his door. When he arrived home around 1621 Hrs he noticed the door was slightly open, and a mark on the front of the door that had not been there prior. The mark on the door was a semi circular indent, which looked as though it could have been cause by the rim of a metal cylinder such as a fire extinguisher. BRILLA stated that nothing in the apartment had been taken or disturbed in any way, and only wished to report it in case further acts happened. BRILLA stated that he did not know of anyone that would have opened his door, and had only been living there for a few days.</p>	
<p>It should be noted that before the incident the door jam had no bracket to secure the door, and the only item keeping the door closed was a screw drilled into the jam. Pictures were taken at the scene by myself of the door and the door jam.</p>
