I drove around the area and saw a male matching the description HAGGARTY gave. The male was in the municipal lot, just north of Geigers. I called out my location and P.O. GREEAR arrived to assist. In speaking with the male, he was identified as ARA/CHRISTOPHER KROST. I advised KROST the reason for the stop. KROST stated he just got off the bus and was walking to The Melt for a rehab meeting. KROST denied being in the area of the Aladdin's restaurant. I asked KROST if he had anything illegal on him and asked to search his person and his bag. KROST became very defensive and asked why he was under arrest. I advised KROST he was not under arrest. KROST again stated he was nowhere near Aladdin's parking lot. I asked KROST again if I could search his person for anything illegal. At that point, KROST turned around and began to run westbound through the municipal lot.

I told KROST to stop several times but he continued running. I advised dispatch I was in a foot pursuit with KROST. Other cars responded to the area to assist. KROST ran south on Warren from the municipal lot towards Detroit. KROST ran westbound on Detroit to Cook. KROST ran north on Cook and ran into the backyard of 1372. KROST tried jumping the fence of 1372 Cook, but was unsuccessful. KROST was escorted to the ground and secured in handcuffs. I asked KROST if he had anything on him that would hurt me or stick me. KROST stated he believed he had a hypodermic needle somewhere on him. After checking KROST, I did not locate a needle on him. Officers checked the area where he went into the backyard, but could not locate any needles or other contraband.

In checking the bag KROST was holding, I located several items. There were electronics, sunglasses, and several other items in the bag. I asked KROST where he got the items and he said they were his. KROST had the listed, silver ring in his right sock. KROST stated it was his and it had an engraving of GS. The ring had no such engraving. All the items were tagged and placed in LPD'S secured storage facility in locker #24.

KROST was secured in car #211 and transported to LPD by P.O. RODA. CO SMITH and I booked KROST for Obstructing Official Business. KROST was advised he would be charged for any of the items in his bag that were reported stolen. KROST was issued citation #M41038 for Obstructing.

INV.FIORITTO spoke to HAGGARTY and he learned the following. HAGGARTY stated she observed KROST try to open five door handles in the parking lot. HAGGARTY stated she saw KROST walk westbound. While officers were speaking with KROST, HAGGARTY arrived on scene and told INV. FIORITTO that KROST was the one she saw in the parking lot behind Aladdin's. INV. FIORITTO spoke to the manager at Aladdin's. INV. FIORITTO was informed that there is video surveillance but was not available until tomorrow.

KROST has a CCH. His BCI# is B495907 and an FBI# of 426558WA4.
