		MO: By breaking in front door, entering abandoned home, and taking listed copper.	
		On 09-11-08 I was detailed to 2020 Warren Road on a call from the City Building Inspector, (COM) WALT MAYNARD, that the front door to that residence had been kicked in. Upon arrival we learned the following.	
		The residence is a double home with addresses 2020/2022 Warren. The house appears abandoned and the front door to 2022 (upstairs) had been completely taken off of the hinges, and was lying on the inside steps. The side door, which is a common door to both units, was also open. There was no forced entry to this door. We entered through the side and into the basement where we noticed that the copper pipe had been cut and taken. We then attempted to check the rest of the residence but the downstairs unit (2020 Warren) was secured at all entry points. We entered the upstairs unit (2022 Warren) and found nothing of value.	
		It is likely that SUS(s) entered the home through the front door of 2022 and then went up and around to the basement. The SUS(s) then most likely left the home through the side door, which they left open.	
		INV. MOHER performed ET, and took photographs, but nothing of value was found. I attempted to speak with the neighbors on either side of the residence but nobody was home. MAYNARD advised that he did not know who owned the property but that he would find out. It was later learned that (VIC) SHANE MANNING is the owner of the property. I phoned MANNING and left a message advising him of the situation. As of this time he had not contacted LPD.
