Topic Original Report

M. O. by entering a residence, through an unlocked window, and taking listed item, without the owners knowledge or consent

On 9/11/08, at 1227Hrs, officers were dispatched to 2057 Robin, on the report of a person running out of a house with a Playstation 3, 20 minutes prior to calling.

Upon arrival we spoke with WIT/ ERIC A. JOHNS, who stated that he had witnessed SUS/ look out the back door and watch the neighbor at 2055 Robin. Then when the neighbor went inside he watched leave through the back door, carrying a Playstation 3. JOHNS stated that he had called the owner VIC/ ANDREY TSYNDRIAN, who said to call the police. JOHNS stated that had run out the back door through the yard, and towards his home, which is behind 2057 Robin on Lark. JOHNS said that he would be able to identify if he was found.

At 2059 Robin there was a female, identified as OIV/ TIFFANY M. ADKINS, who stated that she had seen and another shorter, light skinned, black male in the front of the house prior to JOHNS seeing leave the residence.

INV. MOHER was called for ET and he, PTL. ZBYDNOWSKI, and myself went to 2054 Lark to try and locate , and his friend. At 2054 Lark we spoke with OIV/ LULA B. BRILEY, who is the legal guardian and grandmother of . BRILEY stated that was at school and had not been home since earlier that day. Lakewood high school was contacted by dispatch, and they stated that OWENS was in house 3, and had not been there for 1st or 3rd period, which were the only classes they had attendance from.

It was later found that was known to hang out with males named SUS/ DJ and SUS/ OMARK S. ROGERS.

The home of 2057 Robin was processed by INV. MOHER, photos were taken, and latents were lifted.

While we were at the scene TSYNDRIAN arrived home from work, and assessed what was missing. He stated that he thought some Playstation 3 games and the Playstation 3 were missing. TSYNDRIAN stated that he would talk to his sons when they returned home from school and get a list of all the items missing, and contact us with that list. TSYNDRAIN stated that his wife was the last person in the home, and she left around 1000 Hrs on 9/11/08. When she left the Playstation was still on the TV stand in the south west corner of the house.

I then spoke with the neighbor from 2055 Robin over the phone, who was identified as OIV/ ZAKRIA MANAA. MANAA stated that around 1230 Hrs he had spoken to a black male who was near his garage, and told him to leave. He then witnessed the male head to the street and speak with another black male on a bicycle. MANAA stated that he would be able to identify these males if they were located. MANAA could not give any other clothing or physical discriptions at this time.

Before completing this report TSYNDRIAN called and stated that no games were missing and gave us the serial number to the Playstation 3. TSYNDRAIN desires prosecution in this matter.
