

MO: By engaging in a pattern of conduct leading the victims to believe that the offender will cause them physical harm.		
<p>On 09/11/08, at 2307 Hrs., I was detailed back to 2232 Warren Rd. to speak with (VIC)GENEVA DARLING-RAMOS about her husband, (SUS)JAMES RAMOS, continuously calling her. The phone calls are related to report #LK-08-007510.</p> <p>While en route to the house, dispatch advised that JAMES was in the area, driving past the house in the listed Dodge, and threatening (VIC)NAKIA DARLING. Additional officers responded to the area to search for JAMES, but were unable to locate him. The truck is a white Dodge Ram 1500 Extended cab with a white truck cap on the bed.</p> <p>I went back to 2232 Warren Rd. and spoke to NAKIA and GENEVA. They stated that since the previous incident, JAMES has been calling GENEVA constantly, but GENEVA has been ignoring most of the calls. On one occasion, when she answered the phone, JAMES told her "Don't make me come over there, this won't be over until NAKIA or myself are off the face of the earth". GENEVA then hung up on JAMES.</p> <p>A short time later, NAKIA was walking to his house, from the street, where he just parked his car. He saw JAMES approaching the area from Lakewood Hts. Blvd. in his truck, and told his wife, who was with him, to go inside. It was at this time, that JAMES was back on the phone with GENEVA, and told her that he was there, and for her to look outside.</p> <p>JAMES pulled in front of the house and told NAKIA "This is not over, its going to end tonight", then continued driving north on Warren Rd. JAMES later called back and told GENEVA that he saw officers</p>

	<p>in the area and wanted to know why she called the police. GENEVA again hung up on JAMES.</p> <p>NAKIA and GENEVA again stated that JAMES has several firearms at his home. GENEVA also stated that JAMES told her that he did not care what happens, because he does not have anything to live for. GENEVA and NAKIA both fear that JAMES will act on his threats of bodily harm, and fear for their safety and the safety of NAKIA's family. NAKIA stated that due to JAMES' threats, and the uncertainty of his actions, he removed his children from his home to protect them.</p> <p>NAKIA and GENEVA both desire prosecution for Menacing by Stalking, and NAKIA desires a protection order for him and his family.</p>
