Topic

MO: By removing his jeans and underwear and forcing the female victim onto the couch in an attempt to have sexual intercourse with her without her permission.

9-12-08, Detailed with other cars to 1385 Cranford on report that a male tenant had called stating that a female was screaming that a male was trying to rape her. Upon arrival, Ofc Beno and Inv. Malloy were speaking with VIC/ who advised that the male had left the building. A description of the suspect was obtained and Ofc. Beno and Inv. Malloy left to check the area for the male.

The description was given as a w/m, Italian, approx 50 yrs, approx 5-06 with a thin build. The male was wearing a pair of blue jeans and an unknown shirt and also had a mustache. was unaware of any jewelry or tattoos.

I spoke to while Ofc. Pietch went and spoke to the COM/ JAMES McCONNELL in apt #9 and obtained a statement from him. There were several items located in the living room of 's apartment that she stated belonged to the suspect. These items consisted of a bag of food from Mr. Hero and a black umbrella that were found on the floor approx 5ft from the couch. A black fanny pack was found on a small table in front of the couch. A pair of men's gray underwear were located on the west side of the couch and a cell phone was located on the table to the west of the couch.

gave the following account of the incident: She had just gotten of RTA bus #26, coming from Rocky River, in front of Bobby O's bar at 16013 Detroit. She crossed Detroit n/b, going to her apartment when she saw a male standing at the n/e corner of Detroit/ Cranford. She stated that she knew this male as someone that she had made small talk with while she would wait to get on the bus. She stated that she always sees the male standing outside the bar smoking.

As she crossed the street the male (later identified as ARA/ ANTHONY CIACCHI) asked her where she had been and she stated that she was taking care of business. CIACCHI told her that he was waiting for the bus and he wanted to eat his sandwich. She invited him over to her apartment, because it was raining out, and stated that she was going to eat lunch too.

They walked into the 's apartment and CIACCHI sat down on the couch. She pulled a small table over near him so that he could put his food on it and then went into her bedroom to hang up her sweater. When she came back into the living room she found that CIACCHI had removed his jeans and underwear and was masturbating. She stated that she was shocked by what she saw and told him " this is not what your here for". He told her "yes it is" and he went to her and grabbed her by the shoulders and pushed her down onto the couch. He then went over to her and attempted to pull off her shirt while she was pushing at him to get him away from her.

stated that she kept kicking at him and was able to get up and run to the front door. She stated that when she opened the door a neighbor was walking up the steps. She then asked the neighbor, (later found to be COM/ JAMES McCONNELL), to call 911 because a man was trying to rape her. was out in the hallway at this time had turned towards her door as CIACCHI was coming out. She stated that she pushed him towards the back door and ran into her apartment and locked the door. She stated that it was at this time that she heard the police sirens.

Inv. Malloy and Ofc. Beno advised that they had a male stopped on Orchard Grove that matched the description given by . I drove by the officer's location, where she positively identified CIACCHI as the male that had assaulted her.

I drove back to her residence and obtained a written statement from her. It should be noted that while was giving the account of the incident she was crying and visibly upset. She stated that she did not need medical attention. Inv. Malloy responded for ET after Ofc. Beno placed CIACCHI under arrest and transported him to the station to be booked. I had located a black cloth strap on the west cushion of the couch and asked if she knew what it was to. She looked at her bra and stated that it was her bra strap. I asked her to go into the bedroom and remove her bra so that it could be taken as evidence. It was found that the right strap had been torn off her bra. I asked her if she had any scratches or marks and she stated that she had a burning sensation, like an abrasion, above her right breast. Due to her dark complexion, I was unable to see and abrasions at this time.

Inv. Malloy took possession of all the evidence that was collected and later tagged it and put it into secured storage. See his report for details.

Ofc. Pietch took a statement from McCONNELL who advised that approx 1505 hrs. he entered the apartment building and a black female "bolted" out of the door to apartment . She was screaming that "he's trying to rape me, call 911!" McCONNELL stated that he heard the female yell it 2-3 times. He stated in his statement that she seemed "genuinely terrified" and her blouse was in disarray. he went to his apartment and called the police and he could hear her yelling at the male to get out.

Prosecution is desired.
