Topic Original Report

On 9-12-08, I was on patrol westbound on Detroit near Riverside. I observed a vehicle turn east onto Detroit from Riverside. The vehicle was driving erratically and drove down Detroit Ext. The vehicle turned onto Scenic and proceeded to drive to the dead end. I got behind the vehicle and activated my overhead lights. P.O. PERHACS and P.O. ROMANNELLO arrived to assist.

I approached the driver, later identified as SUB/DANIEL TRAPP, and asked for his driver's license. DANIEL would not respond to any of my questions at first. I noticed a blue coloring around his lips. DANIEL was incoherent and only told me his name was DANIEL. I asked DANIEL what the coloring around his mouth was. DANIEL stated he didn't know what I was talking about. DANIEL was mumbling and hard to understand. I asked DANIEL if he consumed any alcoholic beverages or took any drugs. DANIEL didn't respond but just stared at me. The only information I could get from DANIEL was his first name. I advised DANIEL to step out of the vehicle. DANIEL exited the vehicle after telling him several times to do so.

I continued to try to identify DANIEL. He still would not reply to my questions. I secured DANIEL and placed him in the back of car #217. I had dispatch try to contact the owner of the vehicle, OWN/CHRISTOPHER TRAPP. CHRISTOPHER was contacted and arrived on scene. In speaking with CHRISTOPHER, I learned the following. CHRISTOPHER stated his brother DANIEL was at his house all night. CHRISTOPHER stated he went to bed around 1am. Sometime between 1am and 2:50am, DANIEL went to his business at 13323 Madison and took CHRISTOPHER'S truck. CHRISTOPHER stated that DANIEL has a lot of mental health issues. CHRISTOPHER stated his brother is bi-polar and has seen several doctors recently for many issues. CHRISTOPHER stated he is prescribed one type of medication but believes DANIEL does not take it. While at the scene, SGT. WILKINS and DANIEL'S mother, OIV/EVA TRAPP, arrived.

EVA stated DANIEL went to Ohio State last year and left because of a lot of traumatic events. EVA stated he currently sees Dr. Francois Adon for his depression and bi-polar symptoms. EVA stated he has an appointment on 9-22-08 with another doctor.

I was speaking with DANIEL and CHRISTOPHER about the situation. DANIEL stated he might have taken a half of a bottle of Tylenol PM but doesn't believe he ingested them. DANIEL seemed lethargic and somewhat incoherent. DANIEL stated he did not want to harm himself by taking anything. Squad 2 was called and responded to the scene.

DANIEL was taken by Squad 2 to the ER to be checked out. DANIEL'S family rode with the squad and I followed them to the ER. CHRISTOPHER took possession of his vehicle and also drove to the hospital. DANIEL was to be seen by Dr. Gabrin. I advised Dr. Gabrin of the details and he stated he would most likely be admitted.
