Topic Original Report

M.O.: By forcing open rear door, gaining entry to house, and taking gun, video game systems, video camera, and money, without owners' permission.

Sgt. Gannon, Sir:

On 09/13/2008, at 2320 hours, Inv. Mladek and I were detailed to 1307 Edanola Ave, down, on the report of a burglary. On arrival, we met VIC/JERRY L. BEDOR and VIC/KEVIN J. SKELLY, both of whom reside at the residence.

SKELLY advised that he left the house at approximately 1715 hours, on 09/13/2008. SKELLY specifically remembers locking the front and rear doors, as BEDOR was already at work. SKELLY returned to the house at approximately 2215 hours, on 09/13/2008, and noticed the back door was open. The front door, as well as the windows to the house, remained closed and locked. BEDOR arrived home shortly thereafter, at which point he called LPD.

On arrival, I observed that the back door was open, and that the outside door knob was loose, pulled outwards approximately one inch. This, according to SKELLY, was exactly how he found it when he arrived home at 2215 hours. There appeared to be numerous scratches and scrape marks on door near the handle. BEDOR advised, however, that the door knob had been loose for months, though not that loose, and that most, if not all, of the scratch marks had been there previously. BEDOR advised that, other than the landlord, only he and SKELLY have keys to the residence. Both showed me their keys.

I searched around the house, but was unable to locate an item which may have been used to force open the door. Inv. Mladek processed the scene for evidentiary purposes.

BEDOR stated that a High Point pistol, along with a magazine with six or seven 9mm bullets, was missing from under the mattress in his bedroom. Also missing from his bedroom was a video camera, and approximately \$30 in assorted U.S. currency coins and \$1 bills stored in a plastic container in the top middle drawer in his dresser. The drawers to that dresser, closed when BEDOR left for work earlier that day, were opened.

BEDOR also advised that his X-Box video game system, as well as SKELLY's Nintendo Wii video game system, with its three controllers, were missing from the living room.

SKELLY stated that a plastic bowl, containing approximately \$25 in assorted U.S. currency coins, was missing from a bedside stand in his bedroom.

Neither BEDOR nor SKELLY had serial numbers for any of the indexed property items, but advised they would contact LPD in the event they find them.

BEDOR and SKELLY have no suspects in this matter, but desire prosecution in the event one is located. BEDOR was advised regarding solvability.

I spoke with neighbors at the upstairs address to the house, who did not see anything suspicious. I
