Topic Original Report

MO: By pointing a loaded handgun at four people, who believed he would shoot them.

Sgt Gannon Sir,

On 09-14-08, at 0511HRS., VIC/ALEXANDRA DADAS, VIC/JEFFERSON HUGHES, VIC/DINO ANTONOPOULOS and VIC/GREGORY BAISDEN came to the front counter to report that ARA/DAVID SMITH had pointed a gun at them.

DADAS said she has known SMITH for about 5 years, but had not seen him for a while. She said for about the last two weeks, he has been coming to her job in Cleveland and has been following her to her home in Cleveland. She said he has been begging her to date him. She said that on the night of this report she called HUGHES, her boyfriend, to pick her up from work because she was concerned that SMITH would follow her. HUGHES brought ANTONOPOULOS and BAISDEN with him to pick up DADAS. They said they did not see SMITH until they arrived home at 1580 Coutant.

DADAS, HUGHES, ANTONOPOULOS and BAISDEN all signed statements describing the incident. They said as they arrived at Coutant, SMITH drove by three times in the listed Toyota Camry waiving a black handgun, sometimes pointing it at them. They said by the time they made it from their car to the house, SMITH had gotten out of the car in front of 1580 Coutant, and showed them the handgun, loaded a clip into the handgun and pointed it at them. They said he was saying he just wanted to talk to DADAS, and told them to get away from her. They said SMITH was making gestures with the gun that made them feel he was going to shoot it at them. They said that a white male that they did not know was with SMITH, and the unknown male forced SMITH back into the car. They said that they thought if SMITH's friend had not forced him back in the car he would have shot them. The unknown male was later discovered to be WIT/JUSTIN HOPKINS.

HUGHES said that when SMITH came at them with the gun he called 911 on his cell phone and told the operator to get the police there because there was a male there with a gun who was gonna shoot them. He said he did not hang up the phone because he wanted any shots to be heard by the operator. HUGHES said he waited there for police, and when none came he came to station to report the incident. Sgt Gannon checked in dispatch to see why the 911 call was not answered. Dispatcher Dibacco checked and said they never received that call. We asked HUGHES who he talked to and he said it was C-com emergency. DADAS was advised to contact CPD about incidents that happened in Cleveland.

Inv Deucher, Ptl Brown, Ptl Misch and Ptl Bly went to SMITH's house. Inv Deucher had SMITH come to the back door of the house, identified SMITH and handcuffed him. Ptl Bly and Ptl Brown transported SMITH to the station where he was booked in by Co. McCarthy. SMITH said the gun was in the house. The case for the gun was on a table in the living room, and the gun was sticking out from under the couch. Four magazines were found near the case and a box of bullets. Three of the magazines were loaded. Inv Deucher brought the gun, magazines and bullets and tagged and secured them in locker 24 in the property room. Dispatcher Dibacco checked the serial number on the handgun in CRIS and it came back NIF.

Inv Mladek spoke with HOPKINS, who was in the house with SMITH, and he said he was with

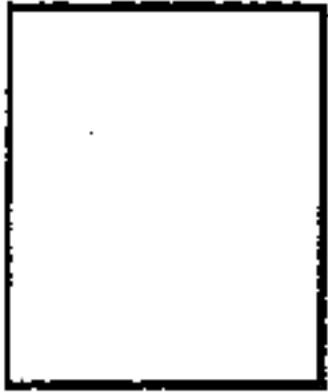

SMITH when he drove by the other parties on Coutant. HOPKINS wrote and signed a statement describing the incident. He said SMITH told him they were going to get something to eat, and did not see SMITH retrieve the gun. HOPKINS said SMITH had the handgun with him on Coutant, and that there was a confrontation.
