Topic Original Report

MO: By using a key to enter residence of another, damaging property, and stealing a television set.

On 09-15-08 I was detailed to 2004 Elmwood, apt. 12, on the report that the apartment was burglarized. Upon arrival i spoke with (VIC) ARIELLE COOKE who advised the following.

COOKE's ex-boyfriend, (SUS) URIAH FULLER moved out of the apartment 3 months ago. COOKE has been afraid to stay at the apartment since FULLER left, so she has been staying with friends. She stated that FULLER never returned her spare apartment key to her. COOKE maintains the apartment and continues to pay rent and keep most of her belongings there. She stated that she locks the apartment every time she leaves. On this date COOKE received a call from a friend of her's who stated that they went to her apartment and found the door open. She immediately responded and found her apartment in complete disarray. There were clothes all over the floor and many of her pictures were torn and thrown all over. COOKE also stated that the listed television set was taken. She does not believe anything else was missing.

In looking at the apartment there was no forced entry on the door or any windows. There were clothes, pictures and papers strewn all over the living room and bedroom. COOKE went on to advise that she has a child with another male, (OIV) DARRELL BOYKINS JR. who is incarcerated. COOKE stated that FULLER is jealous of BOYKINS and that all of the pictures that were ripped up in her apartment were of him. She believes that FULLER came to the apartment, used the spare key to gain entry, and "trashed" all of the pictures of BOYKINS as revenge for COOKE not seeing FULLER anymore. She stated that BOYKINS had also bought the television that was stolen, and FULLER knew this. She also stated that on Friday, 9/12/08, FULLER had left a message on her cell phone stating, "i'm gonna get the last laugh." She stated that she had already erased the message before learning of this incident.

INV. CRUMLEY arrived on scene to perform ET. He photographed the scene but nothing else of evidentiary value was obtained. I called FULLER on his cellular phone, but he hung up on me before we could speak about this incident.

COOKE advised that FULLER is staying with his cousin somewhere on West 98th St. in Cleveland but she is not sure where. COOKE desires prosecution.
