Topic Original Report

M.O.1 By intentionally setting an occupied structure on fire, causing serious physical harm to the structure and a substantial risk of serious physical harm to the occupants.

M.O.2 By intentionally throwing a brick through the victim's car window, causing damage, without permission to do so.

On 9-18-08, at approximately 0218 hours, officers were dispatched to 1448 Alameda on the report of a house on fire. Dispatch advised that the suspect was a male, last seen running southbound on Alameda from the same address. We responded to the scene, while other officers checked the area for the male. Officers searched the area with negative results.

Upon arriving at the scene we observed that the house was on fire, with smoke coming from the upstairs windows. LFD responded to the scene to handle the fire. We were met by VIC/KAREN R. SHEPHERD who advised she was the resident in the home. She stated that no one was injured and everyone was out of the house.

SHEPHERD was on scene with her boyfriend VIC/CHESTER L. JACKSON. KAREN advised that she had a relationship with SUS/ANTONIO L. SMITH in the past, and was letting him stay with her in the upstairs bedroom at 1448 Alameda. He stayed in her room, which was the NE bedroom. KAREN said that she was staying on a mattress in the first floor living room with JACKSON. She wanted SMITH to leave and told him to leave on 9-18-08.

KAREN advised that she and JACKSON were engaging in sexual intercourse in the living room, when SMITH came down from upstairs and went outside. KAREN then heard what sounded like glass breaking. She and JACKSON went outside to find KAREN's back window shattered on her Buick Riviera. Upon exiting the house, SMITH was running southbound on Alameda. KAREN said that she and JACKSON sat outside on the porch for a few minutes. KAREN had to use the restroom, so entered the home and smelled smoke coming from the upstairs. KAREN then called LPD and LFD.

JACKSON gave the same story as KAREN. JACKSON added that when SMITH left the house, he looked outside and saw SMITH pick up a brick, and throw it through the car window. The listed brick was later located on the rear seat floor board of the vehicle. JACKSON also added that he went upstairs after KAREN advised she smelled smoke. JACKSON said that he went upstairs and saw the mattress in the NE bedroom completely engulfed in flames. He confirmed SMITH was staying in that room.

LFD was able to put out the fire. They were unable to provide any details about the cause of the fire at that time. The upstairs of the home was completely burnt from the fire. The downstairs was still in good condition, except for some water leaking through the roof from the upstairs. KAREN's mother, VIC/SHIRLEY R. SHEPHERD, owned the house. She was unable to respond to the scene due to an illness. Statements were taken from both KAREN and JACKSON. They both desired prosecution.

INV. MLADEK responded to process the scene and take photos. The listed brick was taken out of the vehicle by INV MLADEK. He tagged it and secured it in the LPD property room. See INV. MLADEK's report for further details.
