Topic Original Report

M/O: By entering the victim's unlocked residence and taking the listed jar containing miscellaneous coin and without the owner's permission.

Sgt. L. Wilkins,

On 09/19/08, at approximately 2141 Hrs., this officer was detailed to 1446 Cohasset on a report from COM/MARY MASSIMIANI that someone had entered her home and stole the listed coin.

MARY and her daughter, VIC/GINNY MASSIMIANI, advised that someone had forced open GINNY's bedroom door and had stolen a jar full of change. GINNY's bedroom is located in the attic of the home. She uses a hasp with a padlock on it to keep other people in the home out of her room. GINNY stated that prior to MARY contacting LPD, she noticed that someone had forced the door open. She checked her bedroom and noticed that a jar was missing from her dresser. GINNY stated that the jar contained approximately \$30.00 in miscellaneous coin.

In checking the door, the suspect forced the door in causing the screws that held the hasp to the door to pull out of the wood.

INV. ALLEN photographed where the hasp had been pulled free from the door. He found nothing else of evidentiary value. Nothing else was found to be missing from the residence.

When asked about suspects, both believed that SUS/FRANK MASSIMIANI was responsible. MARY advised that FRANK is one of her many foster children. She stated that FRANK has been in rehab for drug addiction for approximately 90 days. She stated that approximately 1 week ago, FRANK was been allowed to leave the rehab center to look for employment. MARY stated that since that time, FRANK has been coming to the house almost daily. MARY and GINNY stated that FRANK has stolen from them in the past, and things have "come up missing" since he began visiting. MARY stated that FRANK was last at the house on 09/18/08. MARY told FRANK that she was going to visit his sister on today's date, and FRANK stated that he wanted to go with MARY. MARY stated that FRANK never came over on 09/18/08 so she went by herself. She stated that FRANK knew when she would be gone.

GINNY added that she had moved in after MARY kicked FRANK out of the house. She believed that this is why he had stolen from her, as he is angered by the fact that he will not be able to move back in while GINNY is living there.

MARY also believed that FRANK is responsible due to that fact that the family's dogs, which are somewhat aggressive, did not scare off any other possible suspect(s). MARY also advised that she never locks the doors to the house when she leaves, and FRANK would have known this.

MARY advised that she had called FRANK's case worker to see when he left the treatment center today but was waiting for the case worker to call her back.

Prosecution is desired.
