Topic Original Report

MO: By forcing open the rear door to the victims apartment, entering inside, and removing electronics and clothing without the knowledge or permission of the victim.

SGT. WYNALEK SIR:

Detailed to 12009 Clifton Blvd. #1 on a report of an apartment that had been burglarized. On arrival, I was met by the victim, VIC/RICHARD S. CLEMONS, who advised the following.

CLEMONS advised that on 9-13-08, at approximately 1100 hours, he left to visit with his sister who lives in Sagamore Hills, Ohio. He did not return home until today at approximately 1510 hours. When he arrived, he entered his apartment through the back door. This door is accessed off an alley that runs along the east side of the building. The parking lot for the building residents is located off Clifton Prado.

Immediately upon reaching his back door, he noticed that the door had been forced open. He entered inside and noticed that his 27", tube style, television had been stolen as well as his Microsoft X-Box 360, DVD player, and cable box/DVR. He also noticed that his hallway closet was open and all of his clothes were dropped onto the hallway floor. He began to check all of his clothes and noticed that his Cleveland Browns #57 Clay Matthews jersey was missing. He described this jersey as his "prized possession." CLEMONS then called this department to report the incident.

In looking at CLEMONS' back door, the deadbolt had been used to secure it. Force was used to open the door, causing the door frame to splinter. This appeared to be the point of entry. This door is hidden from anyone walking on the street. The building is designed with four units to the front and four units to the rear. This is a front apartment. The rear units hid the point of entry from anyone on Clifton Prado. INV. CRUMLEY arrived for ET. See his ET sheet for additional details.

CLEMONS did have the serial number for the television. This television was entered into the computer by DISP. LEWANDOWSKI. CLEMONS did not have the serial number for the X-Box 360. He advised he would attempt to locate the serial number and would contact this department if successful. The listed RCA television is an older tube style set. CLEMONS advised that this television was very heavy and would require at least two people to move. All of the other items were smaller and could easily be carried out of the apartment.

CLEMONS advised that he does not suspect anyone of this crime. He advised that only a few of his friends were aware that he had been gone for the past week. He does not feel that any of his friends would steal from him. He also advised that he recently met a girl named "Katie". He met this girl approximately two or three weeks ago at Corky's Bar. He advised that he did not know her too well but was aware that she lived in Brooklyn, Ohio and works for Progressive Insurance. He said that she has been to his apartment before. He does not think she would have had someone steal his property.

While speaking with CLEMONS, OIV/PATRICK D. HALL arrived. HALL is a friend of CLEMONS and lives upstairs in apartment six. HALL advised that he has not heard anyone inside the building lately, adding that there are two vacant apartments in the front half of the building. He also never heard anyone at CLEMONS' rear apartment door. He also added that he thought he heard CLEMONS' television turned on earlier this morning (9-20-07). CLEMONS advised that he turns his television on when he leaves so that it appears someone is home.

CLEMONS advised that he called his home phone number on 9-18-08 so he could listen to his answering machine messages. At that time, he was not able to access his phone messages and

thought his answering machine was unplugged or broken. When he arrived today, it was unplugged. CLEMONS advised that he would speak with all of his friends, as well as "Katie", to see if they knew anything about this incident. He does desire prosecution in this matter, even if it turns out one of his friends is responsible.
