N A R R A T I V E 1	Topic Original Report	<p>MO: By entering the residence through unknown means, securing the owner's property and leaving the residence with same without the owner's permission.</p> <p>Sgt. Wilkins, Sir:</p> <p>On 9/20/2008, at approximately 1545 hours, I was detailed to the area of 1652 Waterbury-second floor on the report of a burglary. I arrived on scene and spoke with COM/ ROBIN FRANKS and VIC/ JOHN FRANKS. They advised the following.</p> <p>On 9/18/2008, at approximately 1300 hours, the listed HP Pavilion laptop was last seen on a desk located in the Northeast corner of the apartment's living room. On 9/19/2008, at approximately 1300 hours, ROBIN noted that the laptop was no longer on the desk. ROBIN believed that her son, JOHN, removed the laptop and took it to a friend's residence that he was spending the night at on 9/19/2008. As a result of this, she did not contact LPD to report the computer as stolen when it was found not to be on the desk.</p> <p>On 9/20/2008, at approximately 1500 hours, JOHN returned to 1652 Waterbury-second floor. He asked ROBIN about the status of laptop computer. She advised JOHN about what she noted previously. JOHN stated that he did not remove the laptop and did not authorize anyone to remove the laptop from the residence. He looked throughout the apartment and was unable to locate it. He then contacted LPD to report it as being stolen.</p> <p>The apartment is located on the second floor of a three-family double. There is a common hallway that provides access to the second and third floor apartments. This hallway is accessible by an unlocked front door located on the Southeast side of the residence. Outside of the main entrance to the second floor apartment is an unsecured door that leads to the second floor balcony. This balcony is connected to the East exterior wall of the residence. This wall has several unsecured windows. The desk that the laptop sat upon was located next to this exterior wall and windows.</p> <p>ROBIN advised me that the main hallway entrance door remains locked when she and JOHN are not at the residence. However, she also stated that the East windows are not secured and that the screens inside of these windows are not secured. ROBIN denied allowing any persons access to the apartment or permitting anyone to use the two sets of keys to the apartment. JOHN advised the same.</p> <p>JOHN reported that the HP Pavilion laptop computer was approximately one year old. He advised that he did not have proof of ownership or the serial number for this computer at this time. He advised</p>
