Topic Original Report

MO1: By knowingly carrying an unloaded semi-automatic handgun, which was concealed in the front waistband of his pants.

MO2: By being on the city streets between the restricted hours of 2230 and 0600 Hrs., and the restricted hours of 2300 and 0600 Hrs.

On 09/20/08, at 0455 Hrs., officers were detailed to the area of 2191 Riverside on the report that a male was in the complainant's house, had left, and was on foot northbound on Riverside. The complainant described the male as a white male, with a red jacket and blue jean shorts. Dispatch also advised that the complainant said the males name was believed to be "J", a friend of one of her granddaughters. While officers were arriving to the area, PTL HAYES stopped a male at the intersection of Hilliard Blvd. and McKinley Ave. to check him out. This male was eventually identified as (ARJ) K. While officers searched the rest of the area, INV PICKENS located the male that (COM)EUNICE ALEXANDER described, on McKinley Ave. between Hilliard Blvd. and Riverway Dr. The male that was stopped on McKinley Ave. was identified as (ARJ)J

J stated that he went to the house to find his friend, K, who had gone there earlier in the evening. While he was in the house, he was approached by ALEXANDER, who told both males to leave. Once they left, J states he lost contact with K, and he was out looking for him.

While in contact with K, PTL HAYES located an unloaded semi-automatic handgun in K's possession.

I responded to 2191 Riverside Dr. and spoke with ALEXANDER. She stated that she was asleep on the couch and awoke around 0450 Hrs. When she did, she heard the television in (OIV) J's bedroom. When ALEXANDER went to open the bedroom door, she found it was locked. She told J to open the door, at which time she found K, J's boyfriend, inside. ALEXANDER told K to leave, so he did. ALEXANDER then went into (OIV) G's bedroom. When she did, she found J in the bedroom closet. ALEXANDER told J to leave, so he did. ALEXANDER immediately called LPD.

ALEXANDER stated that she is the grandmother and legal guardian of both J and G.

When I spoke to G, she stated that she let both K and J into the house through her bedroom window, which faces east. G stated that both males had been in the house since around 2100 Hrs. on 09/19/08. She said both males were there because they had been kicked out of their houses, and they had no other place to go.

Dispatch advised that K had an outstanding warrant for his arrest out of (GOV)LORAIN COUNTY SHERIFF'S OFFICE, which was confirmed by Sanchez. K was placed under arrest for CCW(m), Curfew, and WOPD. was placed under arrest for Curfew and transported home by INV PICKENS. J was released at his residence to his mother (OIV)HEATHER LABOY.
