<p>M.O. By entering occupied residence through unlocked front window and taking listed items without permission of the owner.</p> <p>Sgt. Wilkins, sir,</p> <p>On 09/21/2008 at 1536 hours, I was detailed to 1418 Lakeland for a Burglary report. Upon arrival, I spoke with VIC/ ALAN E. BALTIS and VIC/ COLLEEN F. BALTIS, who advised the following. COLLEEN stated she left her computer on the couch, in front of the window, in the living room at 0001 hours on 09/21/2008 and then went to bed.</p> <p>ALAN advised at 0700 hours he noticed the computer was not on the couch. ALAN advised the front window, next to the door, was left open, and the computer could easily be seen from the street. ALAN stated the front window shades were up and the screen does not secure. ALAN believes someone reached in the window and took the computer off the couch. The charger was left in place and nothing else is missing. ALAN and COLLEEN both advised they have looked everywhere in the house and have not been able to locate it.</p> <p>The computer is a white Macintosh, 10 inches by 12inches, standard laptop worth about \$1,000.00. ALAN advised they have no suspects and desire prosecution in the event suspects are located. I advised ALAN and COLLEEN of the solvability. ALAN advised he would call LPD if he is able to locate a serial number for the computer. Inv. Geary processed the scene and found nothing of evidentiary value.</p> <p>I spoke with Gynette Guttman who resides at 1422 Lakeland. Guttman advised she did not hear or see anything out of the ordinary throughout the night. There were business to the North and Lakewood Lutheran School to the East.</p>
