	M.O. - By grabbing victim's arm and taking her money without permission.	
	<p>On 9-21-08, at approximately 2334 hrs, officers were detailed to the area of 1586 Winchester on the report of VIC/ MARIA PULIAFICO having observed a male in her vehicle. Prior to our arrival, dispatch advised that the suspect was a white male wearing a dark t-shirt with some type of logo on it, and dark pants. He was last seen N/B on Winchester. Upon arrival, we spoke with PULIAFICO and learned the following:</p> <p>PULIAFICO had spent the day visiting her boyfriend, OIV/ KEVIN PIATAK, at 1586 Winchester. She had parked her vehicle in front of 1595 Winchester. At approximately 2320 hrs, PULIAFICO returned to her vehicle to leave for the evening. When she got to her vehicle, she noticed she had forgotten a pair of shoes at PIATAK's residence. At that time, PULIAFICO placed the property she was carrying in her vehicle, left the vehicle unlocked, and went back to PIATAK's residence to get her shoes. After only a few minutes, she returned to her vehicle a second time. This time she observed the interior light of her vehicle was on, however, she got into the vehicle to leave.</p> <p>At that time, someone grabbed PULIAFICO's right arm. When she looked, there was an unknown</p>

white male sitting in the rear passenger seat of the vehicle. PULIAFICO stated that the male was approximately 20 - 26 years old, 5-8 - 5-10, with dark brown hair, wearing a dark t-shirt with some type of logo or writing on it , and long dark colored shorts. When the male grabbed PULIAFICO's arm, he stated " Be quiet and don't move." The male then began asking PULIAFICO if she had a cell phone or ipod and asked where her wallet was. PULIAFICO told the male that she did not have any of them with her. The male then noticed her purse by her feet and asked what was in it. PULIAFICO picked up her purse and grabbed the money she had in it and gave it to the male. Once the male had the money, he exited the vehicle and ran N/B towards Franklin. PULIAFICO stated she did not see where the male went after that because she was too scared to get out of the vehicle.

After a few minutes, PULIAFICO finally got out of the vehicle and went back to her boyfriend's residence and told him what happened. PIATAK then went outside to attempt to locate the male, but was unable to. After he was unable to locate the male, PULIAFICO contacted LPD. Officers also checked the area for the male, but were unable to locate him.


PULIAFICO stated that she never saw any weapons and was never threatened by the male. She also stated that she would possibly be able to identify the male if she saw him again. She desires prosecution in this matter and was advised of the solvability factors. PULIAFICO also gave a written statement of the incident.

Inv. Pickens responded to the scene for ET work, however, nothing of value was located on the vehicle.

PULIAFICO stated the only thing taken from the vehicle was the listed \$180 in miscellaneous bills that she handed the male while he was in the vehicle.

In speaking with PIATAK, he stated that he did not witness any of the incident, but did attempt to locate the male after PULIAFICO had told him what happened. When PIATAK returned to the residence, after searching for the suspect, PULIAFICO contacted LPD. PIATAK stated that it was approximately 10 minutes after PULIAFICO told him what happened that she contacted LPD. He had no further information at that time.
