Topic Supplemental Report

On 09-21-08 cars were detailed to the area of Magee and Thrush on report of a vehicle that had struck a utility pole. It was reported that the driver of the vehicle appeared to be highly intoxicated. Upon our arrival Unit #1, the listed 1990 Jeep Cherokee, bearing Ohio registration EHJ6949 was parked on Magee at Thrush. The driver of the vehicle was identified as (SUB) KEYES, BRANDON, and the passenger as (OIV) NEWTON, SAMUEL. NEWTON had a small laceration to his forehead from striking the windshield of the vehicle. Lakewood EMS responded to the scene to check NEWTON.

I then spoke with KEYES about the accident. While speaking with KEYES, he had a moderate odor of an alcoholic beverage about his person, his eyes were also bloodshot and glassy and his speech was mumbling and slurred. KEYES stated that he was on his way home from the LIDO Lounge located on W.117th in Cleveland. KEYES stated while at the LIDO Lounge he had two Jack and Cokes and two 12oz Budweisers.

KEYES stated that as he was north on MAGEE, he had to swerve to avoid an SUV that was south on MAGEE. KEYES stated that when he swerved he struck a utility pole on the side of the road. Unit #1 had right front MVA damage consistent with striking a utility pole. The passenger side windshield also was damaged from NEWTON striking it with his head. KEYES claimed no injury and stated he was wearing his seatbelt at the time of the accident.

INV. PICKENS found that the utility pole #321076 on the eastside of the street across from 2086 Magee was the one struck by KEYES. INV. PICKENS took photos of the utility pole and Unit #1. I then obtained the attached statement from KEYES about the accident. After completing the accident investigation, I asked KEYES if he would attempt the Standardized Field Soberity Tests. KEYES agreed to attempt to perform the tests.

KEYES was directed to a level well lit area on Thrush for the tests. INV. FIORITTO assisted during the tests. The first test administered was the HGN. During the HGN all six clues were detected. The next test administered was the One Leg Stand. KEYES was able to complete the One Leg Stand. The last test administered was the Walk and Turn. During the instruction phase KEYES was unable to maintain his balance and took the incorrect number of steps walking down and back. KEYES also lost his balance while completing the turn.

Based on my training and experience and the totality of the circumstances KEYES was placed under arrest for OVI. KEYES was then handcuffed and secured in car 213. KEYES was then advised of his rights and waiver of rights in the presence of INV. FIORITTO. KEYES acknowledged understanding his rights and agreed to answer questions without an attorney present. See the alcohol influence report for further details. A tow was then ordered for the vehicle and KUFNER TOWING responded.

NEWTON refused treatment at the scene and was then placed under arrest for DCI-Intox by P.O. HAYES. NEWTON was issued citation M41044 for DCI-Intox and D165632 for Seatbelt. NEWTON was transported to the station by P.O. HAYES where NEWTON was released to a sober adult.

I then transported KEYES to the station where he was booked by C.O. GONZALEZ and P.O.

ROMANELLO. During the inventory of KEYES's property at booking, C.O. GONZALEZ located a baggie of suspected cocaine in KEYES's open cigarette pack. The baggie was inside a cellophane cigarette wrapper. When confronted with the item KEYES's admitted that the substance was cocaine. See report #08-007758 for details of arrest.

KEYES was then provided with a copy of the ALS form. I then read the form to KEYES in the presence of P.O. ROMANELLO and C.O. GONZALEZ. KEYES was then advised of the test and refusal consequences. KEYES agreed to provide a sample of his breath. KEYES tested .155%BAC at 2239hrs., the intoxilyzer test was administered by P.O. ROMANELLO. KEYES was then advised that he is now under an ALS suspension and his drivers license was confiscated.

KEYES was then booked for Possession of Cocaine 2925.11, OVI and Failure to Control. KEYES was issued citation D163762 for the traffic offenses. A strip search was then conducted according to department policy due to the drug possession charge. The strip search of KEYES was conducted by C.O. GONZALEZ. No further contraband was found on KEYES's person.

The booking tape was then confiscated as evidence. I tagged the booking tape and the cocaine. The cocaine was field-tested with a positive result for cocaine. The gross weight of the cocaine was .33 grams. The cocaine and booking tape were then placed down the chute located in LPD's secured property room. KEYES's drivers license was attached to the ALS.
