Topic Original Report

MO-By cutting out the screen for a window, entering business and taking currency and soda from the area.

Detailed on 9-22-08 at about 1141 Hrs. to 13735 Madison Ave. (CPY/KHIEM'S VIETNAMESE CUISINE) on the report of a business entered and money missing. Inv. Kulczycki also responded to assist. On arrival Officers spoke to VIC/MINH TRAN who advised the following.

TRAN stated she was last at the business on 9-20-08. TRAN closed up the store around 2030 Hrs. that day and did not return until today. On her arrival, TRAN stated that she entered the business through the back door. When TRAN did so, she found it was left unlocked. TRAN stated she is sure the door was secured when she left. TRAN stated that in further checking, she found the screen to the rear window laying on the floor in the kitchen. The screen appeared to have been cut out. In further checking, TRAN found the cash register open and the indexed currency missing. A few cans of the indexed soda were also missing from a cooler in the main dining area. TRAN then contacted her husband who advised her to call LPD and make a report.

In speaking with TRAN, she advised that she may have inadvertently left a window open when she closed on 9-20-08. TRAN stated it was hot that day and she had opened the window to cool off some since she was busy working in the kitchen.

The window in question is located just west of the rear door. The suspect(s) likely entered this window after cutting out the screen. The suspects then climbed in over a kitchen sink, knocking some pans into it and continuing on into the dining area. The register that was targeted is along the south wall at the front of the store. The drawer for the register was closed but could easily be opened by pressing the "no sale" key. The drawer itself was left unlocked. The cooler targeted is also along the south wall of the main dining area but is located further east from the register. The suspect(s) likely then left through the rear door.

Inv. Kulczycki advised that he had located a latent print from the window. See his ET supplement for details. TRAN was advised on the report and given the number for her records.
