Topic Original Report

MO-By entering the victims residence without permission and leaving area with her property.

Detailed on 9-23-08 at about 1413 Hrs. to 1642 Cohasset Ave. #Up on the report of a home burglarized. On arrival I spoke to VIC/CHERYL RAY who advised the following.

RAY stated she left the home on 9-20-08 to stay with her son at his home in Cleveland. RAY stated her son was very ill and needed someone to be with him. RAY returned on this date at about 1345 Hrs. and found the indexed property missing. RAY stated she believed that her roommate, VIC/ROBERT BENJAMIN, was home for the weekend but this was unable to be verified at the time of this report. It is possible that he stayed with his mother at her home in Cleveland. It was also unable to be determined what, if anything, of BENJAMIN's is missing at this time. In later checking CRIS, multiple ROBERT BENJAMIN's were found listed. As such, BENJAMIN's correct MNI information was unable to be located.

RAY stated that she then went downstairs to speak with one of the tenants there. At this time RAY spoke to OIV/ R R then advised the following. At about 1600 Hrs. on 9-22-08, R was getting ready for work. The residents at 1640 Cohasset were outside playing with their children. At some point, the ball they were playing with was tossed up onto RAY's front porch. A male, later identified as SUB/RONALD CLAY, went into his back yard and got a ladder to retrieve the ball. Either CLAY or SUB/BRIAN RICK then climbed the ladder, while the other party held the ladder in place, so they could retrieve the ball. R stated that she heard footsteps upstairs for a few minutes. F was unable to determine if the footsteps stayed on the porch or entered inside the home. R stated she also overheard someone say "no one's home here". R stated a few minutes later the male who went up on the ladder came back down. The ladder was then taken back to the rear of 1640 and the group resumed playing. R left shortly afterwards for work. When advised by RAY that it appeared a Burglary had occurred, R told her about the incident. RAY then called LPD for a report.

In checking the home, no signs of force could be found indicating a point of entry. The likely POE was the unlocked front porch door. The suspect(s) then entered the home and went to the dining room in the south central area of the home. The suspect(s) then removed RAY's property from the area. The indexed television, space heaters and mattress were all last seen along the north wall there. The suspect(s) then left the area. It was unable to be determined if the suspect(s) left through RAY's front or rear door. Both doors were secured when returned home on this date.

RAY advised that she was in a hurry to leave to pick up a friend from work. There was no ET work done at the time of report. RAY was advised that should ET be desired to call LPD back when she gets home.

In speaking with the neighbors at 1640, OIV/ TIFFANY GOAN and OIV/ KRISTI DUNN were advised on the matter. Both females advised a similar account as to that initially told to this Officer by R. Both females denied that their respective boyfriends, RICK and CLAY, had anything to do with the Burglary. GOAN and DUNN were advised on the report.

In later checking, this Officer learned that RAY has an outstanding traffic warrant with
