Topic Original Report

MO: By entering victims unoccupied business by unknown means and taking victims property.

On 9/26/08, at 0417 Hrs., dispatch advised that GOV/CLEVELAND PD was out with a male on Rocky River Drive. CPD. advised the male had a bag of money and receipts from CPY/PUG MAHONES. Officers arrived at PUG MAHONES and found the rear door standing open. The door did not appear to be forced open. INV. REGISTER, INV. DEUCHER and myself checked the business and did not find anything out of the ordinary. Dispatch contacted VIC/KENNETH WAGNER and requested his presence to determine if anything was missing from the business.

SGT. GANNON and I responded to CPD's location. On arrival we spoke with CPD officers Connors and Gurra and learned the following. They observed a male (later identified as ARA/RONALD DALTON) riding the indexed bike with no lights on Rocky River Drive. CPD. initiated a traffic stop. Connors stated as he approached DALTON he observed the listed bottle of Vodka tucked in his waist band. He further advised that DALTON was carrying a purple Crown Royal bag. They asked him what was in the bag and he stated money. CPD. asked to look in the bag and DALTON agreed. The bag contained \$595.25 in cash and several cash register receipts that had PUG MAHONES printed on them. Connors said DALTON first claimed he won the money in a poker game. DALTON then changed his story stating he works at PUG MAHONES and the money was his pay.

While we were speaking with CPD, WAGNER arrived at PUG MAHONES. I was advised By INV. MLADEK that WAGNER stated the Crown Royal bag is used as his cash bag. WAGNER advised that the bag is left in a unlocked cabinet behind the bar by the night bartender. He said he usually arrives at the bar around 0530 Hrs. to pick up the money. WAGNER further advised that DALTON does work at PUG MAHONES as a cook. He said the last day DALTON worked was Sunday 9/21/08. DALTON called in sick on 9/22/08.

DALTON was advised he was under arrest for Breaking and Entering. I read him his Miranda warning and he stated he understood. He stated the money in the Crown Royal bag was his "pay". DALTON made no further statements. He was Transported to LPD by PO. W. MCCARTHY and booked in by CO. D. MCCARTHY for Breaking and Entering.

I responded to PUG MAHONES and spoke with WAGNER. He said to his knowledge DALTON does not have a key to the business. WAGNER stated he does have video recording capability at the business. WAGNER was not familiar with the equipment. He said he would have his manager make a copy of the recording from last night and this morning. WAGNER stated he desired prosecution.

I counted, tagged, and took photos of the money and register receipts. I tagged and took photos of the bottle of Vodka. The stolen money, receipts, and Vodka were returned to WAGNER. He signed the property tags. The bike DALTON was riding was confiscated tagged and secured in the property room.
