Topic Original Report

MO-By opening a secured cable junction box, adding a splitter box and stealing cable television from a legitimate subscriber.

Detailed on this date to the area of 2104 Lark Ave. on the report of cable being stolen. Inv. Malloy also responded to assist. On Officers arrival we spoke to COM/JOSEPH DWYER who advised the following.

DWYER stated that he is an auditor for VIC/COX CABLE. DWYER stated COX CABLE received an e-mail tip that one of the residents at 2104 Lark was stealing cable TV service. DWYER stated the only legitimate subscriber at the apartment building is the resident in #1, OIV/KERRI GAST.

On 9-9-08, DWYER stated he responded to 2104 Lark. At this time DWYER stated he found that the junction box on the north side of the building had been broken into. DWYER was unable to determine when this may have occurred. DWYER found that the suspect(s) added their own splitter, which can be commonly found at any drug or discount store, inside the box and sent the cable service off to their respective residences. These were later found to be apartments #2 and #3.

DWYER stated that he placed a service cut off notice on the front door to those apartments. DWYER stated that the cut off notice advises the resident that if the cable service that was terminated was done so in error, to call COX CABLE back so service can be restored. To DWYER's knowledge, no phone call has ever been made. It should be noted that DWYER had resecured the junction box with a new lock and hasp prior to his leaving that day. Also, no one was home at either apartment at time he found the damage to the box.

DWYER then took photographs of the scene and then cut the cables leading to apartment #2 and #3. The cable leading to apartment #2 was found to run east from the junction box upstairs to a window on the second floor. The cable leading to apartment #3 ran west from the junction box into a bedroom window on the first floor.

DWYER stated he returned to the building on 9-22-08 for follow up with the residents of #2 and #3 since they were unable to be spoken with on 9-9-08. At this time, DWYER found that the junction box had been broken back into again. Someone had cut the hasp and added another splitter to the box. Another cable line had been strung back to the same window at apartment #2 as DWYER previously found it on 9-9-08. No new cable line had been strung to apartment #3. DWYER then took some additional photographs, resecured the box and left the scene. DWYER then responded back to the building on this date after calling his supervisor and LPD for a report.

Inv. Malloy took photos of the box at this time. See his photo sheet for details. DWYER then cut the cables and placed an additional cut off notice on the door to #2. Again, no one was home at either apartment at the time of this report. The names on the mailboxes indicate SUS/HANNA, SUS/ROGERS and SUS/CLEMENS live in #2. SUS/K. GALLAGHER lives in #3. Nothing further was found on any of these parties in checking a SAS through CRIS.

DWYER then supplied this Officer the indexed photos. The photos were later transported, tagged and placed into locker #12 to be held as evidence. DWYER was then given the report number for his
