M.O.: By being in possession of a schedule III substance, to wit: two Vicodin tablets, and not having a prescription to permit possession of same.		
Lt. Ciresi, Sir:		
<p>On 9/24/08 at 1515 hrs, I was driving north on W.117 from Madison when I observed a male sitting on the front step of Bottom's Up, 1572 W. 117st. As I passed by the male, I immediately noticed that he was ARA/MATTHEW GURKO, a male that I had an active warrant on for possession of cocaine. I checked with dispatch and learned that the warrant was still active. Det. Guzik responded to the area to assist.</p> <p>GURKO was stopped as he was walking in front of the business. GURKO was handcuffed and advised of the warrant. During a search of his person, I located two white tablets in his right front pants pocket. GURKO identified the two tablets as vicodin and added that they were given to him and he did not have a prescription for them.</p> <p>GURKO was transported to the station and booked in on the warrant. While in LPD custody, GURKO was issued misdemeanor citation #39669 for drug abuse.</p> <p>It should be noted that GURKO also has an active warrant with GOV/WESTLAKE P.D. for a traffic offense. This warrant was confirmed with Westlake at 1604 hrs.</p> <p>The two pills were tagged as evidence and secured in the property room.</p>
