Topic Original Report

M.O. Attempting to cause physical harm by pushing the victim in the face, causing her to fall to the floor, resulting in scratches and bruising to her face and back.

On 9-28-08, at approximately 1905 hours, officers were detailed to the area of 1276 Cook on the report of a female being assaulted. On arrival, PO LEANZA and I spoke with VIC/ELIZABETH M. DOBRZYNIIECKI. DOBRZYNIIECKI stated that two former neighbors assaulted her. She said she used to live in Cleveland in one half of a double house, with SUS/ELIZABETH A. EVERMAN and SUS/STEPHONE living in the other half. DOBRZYNIIECKI did not know STEPHONE's last name, and we were unable to locate any further information from the computer. Both EVERMAN and STEPHONE left the scene in a black Pontiac Grand Am prior to our arrival. Officers checked the area, but we unable to locate the vehicle.

DOBRZYNIIECKI stated that the fight started over a motorized toy that EVERMAN and STEPHONE were supposed to store for her. When DOBRZYNIIECKI realized that the toy was gone, she called EVERMAN and STEPHONE "thieves."

EVERMAN then confronted DOBRZYNIIECKI, at her current residence in Lakewood, about the statements and pushed DOBRZYNIIECKI in the face, causing her to fall back onto the porch floor. The push caused DOBRZYNIIECKI to have a partial black left eye, scratch on her right temple, and redness on her lower back. DOBRZYNIIECKI also advised that STEPHONE then pushed her sister, WIT/JOANN C. EAKLE. EVERMAN and STEPHONE then left the area and EAKLE called LPD. We spoke to EAKLE, who advised that she was not injured and did not wish to press charges. EAKLE gave the same version of events as DOBRZYNIIECKI.

DOBRZYNIIECKI's injuries were photographed by PO LEANZA. She declined medical attention. DOBRZYNIIECKI provided a written statement, and advised that she desires prosecution.
