Topic Original Report

MO: Be being in possession of a vehicle that is stolen.
 MO: Be fleeing from the police in a motor vehicle and reaching speeds of over 70 mph. in a residential neighborhood thus creating a substantial risk of serious physical harm to persons or property.
 MO: By having in his possession a flat headed screwdriver that was used to break the window and peel the column of the vehicle in order to steal same.
 MO: Be being 16 years of age and being out on the city streets between 2300 hrs. and 0600 hrs.

LT. WARNER SIR,

On 09/28/08 at approximately 0433 hrs. this officer was on patrol on Athens W/B at Waterbury. I stopped for the stop sign and could hear a car coming N/B on Waterbury at a high rate of speed. A Dodge Stratus came N/B at a high rate of speed and attempted to stop for the stop sign, at Athens, but skidded through the intersection. I turned N/B on Waterbury and the Dodge accelerated rapidly away from this officer. I activated the lights and siren in car 210 and started to pursue the vehicle.

I advised Dispatch that I was in pursuit of the vehicle and I could see that there was a black male driver. As the vehicle was going N/B on Waterbury it reached speeds of 70 mph. Traffic was light. The Dodge did not stop or slow down for the stop sign at Madison, continued N/B on Waterbury and continued to accelerate. The Dodge continued N/B on Waterbury and attempted to turn W/B on Franklin. The Dodge lost control and struck the utility pole on the north-west corner of Waterbury and Franklin. The driver jumped out of the car and started to run in a south-west direction. Other officers responded to the area and a perimeter was set up. PO OBROCK was notified to respond to the scene.

This officer checked the interior of the Dodge and noted the column was peeled and the driver's passenger window was shattered out. While officers were on the perimeter, SGT. GANNON spotted the male running W/B through the yards from Sullivans Pub on Madison. Officers started chasing the male and PO MULLEN spotted the male on Elbur Ave. The male started running back east. PO MULLEN and PO W. MCCARTHY located the male in the yard at 1672 Lewis Ave. He was placed under arrest for RSP.

The male was identified as . The male was advised of his rights and stated that he understood his rights. He was asked about the car. He stated that he knew the car was stolen, but was not the person that stole the car. He was given the car by another male, but he could not give the other male's name. PO LEANZA transported to the station where he was booked by CO DAN MCCARTHY. It was learned that was 16 years old and did not have a license. He was also not wearing a seat belt at the time of the crash. In checking the Dodge, there was a flat head screwdriver located on the driver's seat and also a pair of gloves. These items were taken as evidence by INV. MLADEK. INV. MLADEK also handled the crash report under report # 08-007934. He also took photos of the crash scene and of the vehicle.

The car listed to JOHNSON. Cleveland Police were notified and responded to her house to notify her of the car being stolen. The car was towed from the scene by Kufner Towing. The gloves and the screwdriver were tagged as evidence and placed in locker #17 in the evidence room. JOHNSON responded to the front counter of the police station and this officer spoke to her. The car was parked on W80th, north of Detroit. One of her sons was driving the car and last saw the car around midnight,
