<b>N A R R A T I V E</b>	<b>Topic</b> Original Report	<p><b>1</b> MO- By engaging in conduct that appeared to be fighting causing inconvenience, annoyance, and alarm to residents in the area</p> <p>MO- By having a cigar and lighter in his pocket and being 15 years of age</p> <p>On 09/28/2008, at 2032hrs, cars were detailed Code 3 to COOK and the RAILROAD TRACKS on the report of several black males assaulting another male.</p> <p>PTL. MINTEER arrived on COOK first, and advised other officers that the males ran Westbound along the tracks to the first house South of the tracks on the West side of GLADYS. INV. MLADEK and I arrived on GLADYS shortly thereafter. We observed several parties sitting on the front steps of 1324 GLADYS.</p> <p>These parties were told why we were there, and they indicated they were "play fighting" at COOK and the RAILROAD TRACKS. The males were identified as (ARA)WRIGHT, (ARJ) , and (ARJ) . PTL. THIBODEAUX located (ARJ) behind 1324, and walked him out front.</p> <p>The males were advised they were under arrest for Disorderly Conduct. WRIGHT was issued Citation #M41367 for Disorderly Conduct and released at the scene. PTL. MINTEER searched incident to arrest and locate a cigar and lighter in his pocket. was issued Citation #D165544 for Tobacco Use By Children. (OIV)ROGERS was on-scene, and took custody of and ROGERS is 's father and 's uncle. He was also related to 's grandparents(AMOS and ROSY WEBSTER) have custody of him. They were unable to get to LAKEWOOD to pick him up, so ROGERS took custody of him.</p> <p>INV. MLADEK obtained a statement from (WIT)BOUCHARD. BOUCHARD said he observed the males being loud and horse playing. He then saw them fighting with another single male. This male was punched and knocked to the ground. Officers checked the area for the male, but were unable to locate him.</p> <p>ROGERS was cooperative and tried to explain to the males that they shouldn't have run, and also the significance of how their behavior was interpreted by residents.</p> <p>Record Room: WRIGHT is ARA for Disorderly Conduct. , and are ARJ for Disorderly Conduct. is ARJ for Tobacco Use By Children. CITY OF LAKEWOOD is VIC of Disorderly Conduct. STATE OF OHIO is VIC of Tobacco Use By Children.</p>
