Topic Original Report

On 9/29/08, at approximately 1533 Hrs, officers were dispatched to 1533 Belle on the report of a car parked in front of the house, and the people inside the vehicle had guns.

Upon arrival I spoke with COM/ [REDACTED] and COM/ [REDACTED], who stated that there were four white males inside a black vehicle with two guns. They stated that the males had shouted to a pedestrian, OIV/ [REDACTED], that they had guns. They said they knew [REDACTED] from school. [REDACTED] stated that he had seen one gun in the waist band of one of the males, and another male had a gun in his hand.

[REDACTED] stated that three of the males in the car had on white t-shirts, and the fourth male had dark hair and a black t-shirt. [REDACTED] also stated that the vehicle looked like a Dodge Intrepid that was parked up the street, only black, with two doors, and a spoiler. [REDACTED] gave a partial plate for the vehicle of EFM. He could not give any further information other than the vehicle went east on Franklin, and [REDACTED] walked west on Franklin.

[REDACTED] did not have any further information about the vehicle or subjects at this time.

Officers were unable to locate any vehicle matching this description.

[REDACTED] was contacted by phone, by PTL. ZBYDNOWSKI, and she stated that there were only three males about 18 years old in the vehicle, two were white with unknown clothing, and one was Hispanic. The Hispanic male had a white tank top, had short dark hair, was 5'10" to 5'11", and had a gun.

[REDACTED] stated that the males were chasing another male named [REDACTED]. [REDACTED] is about 5'10", with a thin build, white shirt, and blue shorts. She stated that [REDACTED] was her friend and they were walking together, but she had no further information about [REDACTED] at this time. [REDACTED] stated the vehicle looked like a black Honda 2 door hatchback with silver rims.

[REDACTED] and her mother were advised to locate [REDACTED] to acquire any information he has about the males that were in the vehicle.
