Topic Original Report

M.O. - By creating a disturbance and continuously yelling, swearing and attempting to get others to fight her, after being told several times by officers to desist.

On 9-29-08, at approximately 1859 Hrs, officers were detailed to the area of 1551 Lakewood on the report of people out front wanting to fight. Upon arrival, officers observed approximately 15 - 20 people outside yelling. Officers first spoke with COM/ DELILAH BRUTON, who was highly upset and yelling that the females standing across the street, had come to her residence to fight.

As officers were trying to get people calmed down, most of the parties went into the residence or onto the front porch of 1551 Lakewood. ARA/ ASHLEY WILLIAMS, however, was also highly upset and was yelling and swearing at the females across the street. She was walking around on the sidewalk and in the front yard attempting to get the other females to come across the street and fight her. WILLIAMS refused to stop her disorderly behavior after Ptl. Schad and I advised her to do so several times. After several warnings, WILLIAMS was placed under arrest for Disorderly Conduct Persisting. WILLIAMS was handcuffed and secured in the back of 203. At that time, everyone else was able to be calmed down and officers were able to speak to the people involved.

In further speaking with BRUTON, she stated that the three females, identified as OIV/ VERONICA SHANKLIN, OIV/ IKEYA JACKSON, and OIV/ \_\_\_\_\_, came to her residence to start a fight with her. BRUTON stated that SHANKLIN was telling her that her daughters, JACKSON and \_\_\_\_\_ were being harassed by people when they walked by BRUTON'S residence. BRUTON stated that she was unaware of this and was not home when SHANKLIN first arrived at the residence yelling for BRUTON to come outside and fight her if she had a problem. BRUTON stated that SHANKLIN was threatening her, but would not elaborate on the threats. She just continued saying that SHANKLIN came to her house looking to fight.

In speaking with SHANKLIN, JACKSON, and \_\_\_\_\_, they stated that every time they walk past BRUTON'S residence, JACKSON and \_\_\_\_\_ are being harassed by people there. SHANKLIN stated that she attempted to speak with BRUTON on 9-28-08 about the situation, but BRUTON was not very receptive toward SHANKLIN and became upset with her about the conversation. SHANKLIN left at that time, but returned to the residence on 9-29-08 to attempt to speak with BRUTON again. SHANKLIN stated that BRUTON again became very upset and several of her family members came out of the residence yelling at her and wanting to fight. That was when LPD arrived.

WILLIAMS gave a similar version of events as to how the disturbance had begun. However, according to WILLIAMS, SHANKLIN, JACKSON and \_\_\_\_\_ were the ones who had started the incident by coming to BRUTON'S residence wanting to fight.

After speaking with the people involved in the incident, SHANKLIN, JACKSON, and \_\_\_\_\_ were advised not to return to BRUTON'S residence for any reason to avoid any further problems.

I then transported WILLIAMS to LPD where she was booked in by C.O. Bunner and Disp. Sykora for Disorderly Conduct Persisting (M4). She was issued citation #M41585.
